JAMESTOWN CITY COUNCIL REGULAR MEETING, OCTOBER 2, 2017 OFFICIAL MINUTES

The regular meeting of the City Council was called to order by Mayor Andersen at 5:00 P.M.

The Pledge of Allegiance to the flag was recited.

Roll Call showed the following members present: Mayor Andersen, Council Members Phillips, Gumke and Buchanan, City Attorney Ryan, and City Administrator Fuchs. Absent: Council Member Brubakken.

Council Member Buchanan moved to approve the minutes of the regular council meeting, September 5, 2017; budget meeting, September 13, 2017, and committee meeting, September 19, 2017. Seconded by Council Member Phillips. Unanimous aye vote. Carried.

No bids were received for impounded/abandoned vehicles.

One bid was received from Northern Technologies, LLC, in the amount of \$52,915.00, for the installation of Monitoring Well System Upgrades at the Municipal Sanitary Landfill.

Council Member Phillips moved to approve the following consent agenda items:

Seconded by Council Member Gumke. Consent Roll Call No. 1 showed: 4 ayes, 0 nays, 1 absent. Carried.

Council Member Gumke moved a Resolution to approve and authorize the issuance and sale of \$900,000 Wastewater Treatment Revenue Bond, Series 2017B. Seconded by Council Member Phillips. Roll Call No. 2 showed: 4 ayes, 0 nays, 1 absent. Carried.

Council Member Gumke moved a Resolution to approve and authorize entering into an agreement with Interstate Engineering, Inc., for engineering services on construction of sidewalk along 12th Ave NE from 5th St NE to 13th Street NE and sidewalk between Two Rivers Activity Center (TRAC) and the Jamestown High School. Seconded by Council Member Phillips. Roll Call No. 3 showed: 4 ayes, 0 nays, 1 absent. Carried.

The City Council took no action on a letter from Paul Ebertz, requesting the variance granted to Tim Newton which would allow the construction of a garage exceeding the statutory lot coverage maximum of the property at 1418 5th Ave. NE be rescinded, as the City Attorney determined the request had no standing and Tim Newton had also decided to build a garage of sufficient size as to be in conformity with the statute.

Council Member Gumke moved a Resolution to award the bid for the installation of Monitoring Well System Upgrades at the Municipal Sanitary Landfill to Northern Technologies, LLC, in the amount of \$52,915.00. Seconded by Council Member Buchanan. Roll Call No. 4 showed: 4 ayes, 0 nays, 1 absent. Carried.

Council Member Buchanan issued a thank you to the members of the Stutsman County Dive Team and the James Valley Special Operations Team for their dedicated service to the community.

A public hearing was held, at 6:00 PM, concerning the proposed budget for City General and Special Funds for the fiscal period January 1, 2018, through December 31, 2018.

Herbert Schulz, 1611 Island Park Drive, appeared to express his concerns regarding tax increases from all local entities.

Ordinance No. 1499, introduced by Council Member Buchanan, pertaining to the appropriation of the General and Special Funds for the fiscal year January 1, 2018, through December 31, 2018, had its second reading. Seconded by Council Member Gumke. Roll Call No. 5 showed: 4 ayes 0 nays, 1 absent. Carried.

Ordinance No. 1500, introduced by Council Member Phillips, pertaining to the appropriation of the Revenue and Special Funds for the fiscal year January 1, 2018, through December 31, 2018, had its second reading. Seconded by Council Member Gumke. Roll Call No. 6 showed: 4 ayes 0 nays, 1 absent. Carried.

Council Member Gumke moved a Resolution to direct the City Administrator to notify the County that the City of Jamestown should be exempt from the County Library Levy as the City maintains its own library levy. Seconded by Council Member Phillips. Roll Call No. 7 showed: 4 ayes 0 nays, 1 absent. Carried.

Council Member Buchanan moved a Resolution to direct the City Administrator to certify the tax levies to the County for the fiscal period January 1, 2018, through December 31, 2018. Seconded by Council Member Gumke. Roll Call No. 8 showed: 4 ayes 0 nays, 1 absent. Carried.

Council Member Gumke moved to adjourn. Seconded by Council Member Phillips. Unanimous aye vote. Carried.
