Andersen moved to recommend the City Council approve an Amendment to Lease and Option between JSDC and Goodrich Corporation. Seconded by Buchanan. Unanimous aye vote. Carried.

Andersen moved to recommend the City Council recognize Jakestar, Inc. as an other public spirited organization and to authorize the issuance of a raffle permit, with the drawing to be held January 16, 2016. Seconded by Kourajian. Unanimous aye vote. Carried.
