- 2. **Public Hearing**: The Stoudt Lot Combination- Lots 10, 11, and 12, Block 15 of Atkinson and Panell's Addition and South Half of Vacated 19th Street SW and West Half of Vacated Alley, Jamestown, North Dakota. The property is located at 1909 4th Ave SW.

Tom Blackmore gave a staff report of the lot combination. Applicant would like to combine lots for development expansion. Chairman Hillerud opened the public hearing. No one was present for the public hearing. Chairman Hillerud closed the public hearing. There were no questions. 3. **Public Hearing:** The Schlecht Lot Combination- Lots 5 & 6 Block 4 of Country Side Estates, Jamestown, North Dakota. The property is located at 1304 & 1316 Foxtrot Road.

Tom Blackmore gave a staff report of lot combination. Applicant is requesting lot combination to build new home on this property. Chairman Hillerud opened the public hearing. There was no one present for the public hearing. The public hearing was closed. There were no questions or comments on this lot combination. Trautman made a motion to approve. Seconded by Bensch. Roll call. 8 ayes, 0 nays, 1 absent. Motion carried.

Blackmore stated that the City Engineering Department is working with the NDDOT on this and there is no immediate action on this intersection at this time. Tyler Michel, City Engineering Tech, stated that the NDDOT is working on alleviating the pressure on this intersection by steering traffic to other intersections. There is no timeline on, when or if this will occur. Matt Mrochinski, Excel Engineering, discussed the plans and drawings of this project. Beings that this possible intersection change is not in the near future at this time, there's no reason to not approve the lot combination. Chairman Hillerud made a motion to approve the lot combination.
