GUIDELINES FOR REQUESTING VACATION OF STREET, ALLEY OR RIGHT-OF-WAY

A request to vacate a street, alley, or right-of-way requires the following:

- 1. Completion of the attached application form (2 pages).
- 2. Payment of the established application fee which must be submitted with the signed application form. (Applicant will be billed for any city costs in excess of the application fee.)
- 3. The City Auditor, <u>upon receipt of a completed application (2 pages) for the vacation and collection of the application fee</u>, will publish notice of a public hearing to be held at the first regularly scheduled City Council meeting possible to comply with the public notice requirements. (Notice must be published once each week for four (4) weeks with the public hearing held no sooner than 30 days from the first publication.)
- 4. The public hearing must be held prior to action by the City Council.
- 5. Upon approval of a resolution for vacation, the City Auditor shall file the Resolution of Vacation with the Stutsman County Recorder's Office and publish said Resolution one time.
