ITEMS NOT ACCEPTABLE IN CONSTRUCTION/ ROLL-OFF CONTAINERS

1. NO RESIDENTIAL GARBAGE BAGS OR WASTE OF ANY TYPE.
2. NO APPLIANCES (REFRIGERATORS, DISHWASHERS, WASHER & DRYERS, FRREZERS, KITCHEN RANGES OR FURNACES). THESE ITEMS CAN BE TAKEN TO THE LOCAL SCRAP YARD.
3. NO TELEVISIONS, STEREOS, MICROWAVES, COMPUTERS OR COMPUTER COMPONATS, HUMIDIFIERS, ECT.
4. NO BATTERIES OF ANY TYPE (TAKE TO LOCAL SCRAP YARD).
5. NO PAINTS OR LIQUIDS OF ANY TYPE. THESE CAN BE BROUGHT TO THE BALING FACILITY TO BE RECYCLED.
6. NO OILS, PETROLEUM PRODUCTS OR CONTAMINATED FLOOR DRY.
7. NO FOOD PRODUCT OF ANY TYPE, CANNED OR OTHERWISE.
 - a. NO EMPTY FOOD PRODUCT CONTAINERS, SODA CANS OR BOTTLES, WATER BOTTLES OF ANY TYPE. NO PAPER OR CARDBOARD. THESE PRODUCT CAN BE RECYCLED AND SHOULD GO TO THE RECYCLING CENTER IF NOT ABLE TO FIT IN YOUR RESIDENTIAL RECYCLE CONTAINER.
8. NO MEATS, MEAT PRODUCTS OR ANY PART OF ANIMAL CARCASS, DOMESTIC OR NOT. NO WRAPS OR CONTAINERS THAT HAD MEAT IN THEM.
9. NO METAL. (THESE CAN BE TAKEN TO THE LOCAL SCRAP YARD).
10. NO AIR CONDITIONERS OR ANY ITEM THAT CONTAINS OR HAD CONTAINED FREON.
11. NO AUTO, TRUCK, TRACTOR TIRES OR RUBBER TRACKS FROM TRACTORS OR HEAVY MACHINERY. (THESE ITEMS CAN BE BROUGHT TO THE BALER, THERE WILL BE A CHARGED ACCORDING TO TOTAL COUNT).
12. NO BIO-MEDICAL ITEMS: SHARPS, BLOODBORNE ITEMS SUCH AS CLOTHING, FURNITURE, CARPET OR WALL MATERIALS THAT CONTAIN ANY BLOOD.
13. NO FLOURESCENT BULBS OF ANY TYPE, NO LIGHT BULBS. THESE CAN BE BROUGHT TO THE BALER, THERE WILL BE A CHARGE PER BULB.
14. NO BALLAST CONTAINING LIGHT FIXTURES.
15. NO CONTAMINATED SOILS (CONTAMINATED BY PETROLEUM PRODUCRTS, BARNYARD WASTE, LIVESTOCK WASTE BLOOD OR SEWAGE).
16. NO ASBESTOS CONTAING MATERIALS: FLOORING, SIDING, CEILING TILES OR INSULATION (INLESS IT IS THE ONLY THING IN THE CONTAINER AND HAS A MANIFEST AND PRIOR APPROVAL).
17. NO GRAINS OR GRAIN BYPRODUCTS OF ANY TYPE.
18. NO GRASS, TREES, OR PARTS OF TREES. NO GARDEN VEGETATION OR MATERIALS. (THESE CAN BE BROUGHT TO THE COMPOST SITE LOCATED BY THE BALING FACILITY).
19. NO LUNCHROOM DEBREIS OR LUNCH MATERIAL FOOD, WRAPS, CONTAINERS, BOTTLES OF ANY TYPE DRINK OR FOOD BOTTLES EMPTY OR NOT.
20. NO RAILROAD TIES, TELEPHONE POSTS OR ANY WOOD CONTAINING CREOSOTE.

*RENTAL FEES ARE \$3.50/ DAY OR \$70.00 / MONTH.

*CALL BALER FOR CONTAINER TO BE DUMPED.

*HAUL CHARGE FOR THE DUMPING OF CONTAINER IS \$195.00 / DUMP, PLUS TIPPING FEE PER TON.

***DEPOSITS ARE NOT RETURNED UNTIL ALL INVOICES HAVE BEEN PAID IN FULL. NO PARTIAL PAYMENTS ACCEPTED.**

***IF CAUGHT DUMPING ANY OF THESE MATERIALS, THERE WILL BE AN ADDITIONAL CHARGE OR FINE.**

***IF INVOICES ARE CONTINUALLY NOT PAID, YOU WILL NO LONGER BE ALLOWED TO RENT A CONSTRUCTION/ ROLL OFF CONTAINER FROM THE CITY OF JAMESTOWN.**

WHERE TO DISPOSE OF PRACTICALLY ANYTHING

Garbage - Dispose in your garbage cart or take to the City Baler/Landfill. Each household may dispose of 500 pounds at no extra charge each month at the City Baler/Landfill. Must show proof of city residency. City Baler/Landfill hours: Monday-Friday, 8:00 a.m. to 3:30 p.m. & Saturday, 8:00 a.m. to 11:30 a.m.

Recycling - Contact Recycle ND with questions about recycling. Cardboard, newspaper, white paper, colored paper, books, magazines, unwanted mail, cereal boxes, aluminum cans, tin cans, most plastics, sorted glass, clothing, and shoes are accepted at the Recycle ND Facility. Recycle ND Hours: Tues/Thurs/Fri/Sat, 9:00 a.m. to 1:00 p.m. and Wed, 1:00 p.m. to 5:00 p.m.

Appliances, boats, metals, vehicles, vehicle batteries - Take to Gerdau Ameristeel or West End Hide, Fur & Metal Co. There may be a disposal charge for these items.

Electronics, fluorescent or mercury vapor light bulbs, boats, building/remodeling, construction & demolition debris, metals, paint, solvents, thinners, primers, varnishes & stains - Take to the City Baler/Landfill. Liquids must be in original containers with a readable label.

Tires and automotive oil - may be taken to the City Baler/Landfill. Must show proof of city residency. There may be a disposal charge for some of the items.

Yard Waste - can be taken to the City Baler/Landfill drop off site.

Snow blowers, lawn mowers, propane tanks, and metal gas cans can be taken to Gerdau Ameristeel, West End Hide & Fur, and the City Baler/Landfill. Drain liquids and gas; leave caps or valves open on the containers or tanks for safety reasons. **Plastic gas containers with no liquids** can be taken to the City Baler/Landfill.

Bio-medical waste - Contact Central Valley Health, Jamestown Regional Medical Center, or your local clinic or pharmacy for instructions.

Clothing and Shoes – If clean, donate to local Goodwill or other charitable organizations. If not suitable, take to Recycle North Dakota or dispose in trash.
