



**ALL** License types must submit COMPLETED APPLICATION & REQUIRED ITEMS as listed below **BEFORE** the License Expiration date.

**NEW APPLICANT:** License Surety Bond shall be made out in favor of the City of Jamestown to expire December 31<sup>st</sup> of License year or beyond; SIGNATURE of the PRINCIPAL and the Attorney-in-Fact **MUST BE NOTARIZED.**  
**SURETY BOND REQUIRED.**

**RENEWAL APPLICANT:** **\*\* RENEWAL FEE, Application, Surety Bond and/or Continuation Certificate MUST BE received by DECEMBER 31<sup>st</sup>; INITIAL LICENSE FEE WILL APPLY if ANY Items are RECEIVED AFTER DEC 31<sup>ST</sup> \*\***

**BUILDING CONTRACTOR** - Initial license fee of \$250.00 OR **\*\* Renewal fee of \$85.00....AND**

- \$10,000 License Surety Bond (New Applicant) or a Continuation Certificate (Renewal Applicant)
- Copy of current ND State Contractor's License

*License period – January 1<sup>st</sup> to December 31<sup>st</sup>*

#### **ELECTRICIANS**

**MASTER ELECTRICIAN** - Initial license fee of \$250.00 OR **\*\* Renewal fee of \$85.00....AND**

- \$10,000 License Surety Bond OR Continuation Certificate (Renewal Applicant)
- Certificate of Liability Insurance with minimum limits (See Application)

**JOURNEYMAN ELECTRICIAN** - **License fee of \$55.00** (Note: Must have a licensed Master Electrician before Journeyman can be licensed)

*License period – January 1<sup>st</sup> to December 31<sup>st</sup>*

**PLUMBERS**-NOTE: If the SAME individual is applying for BOTH a Master Plumber and a Gas Fitter License, indicate this on the application form with individual's name.

**MASTER PLUMBER** - Initial license fee of \$250.00 OR **\*\* Renewal fee of \$85.00....AND**

- \$10,000 License Surety Bond (New Applicant) or a Continuation Certificate (Renewal Applicant)
- Certificate of Liability Insurance with minimum limits (See Application)

**JOURNEYMAN PLUMBER** - **License fee of \$55.00**

**GAS FITTER** - **License fee of \$65.00....AND**

- \$10,000 License Surety Bond (ALL Applicants)
- Certificate of Liability Insurance with minimum limits (See Application)

*License period – January 1<sup>st</sup> to December 31<sup>st</sup>*

**EXCAVATING, PATCHING & CURB CUT** - **License fee of \$55.00....AND**

- \$25,000 License Surety Bond

*License period July 1<sup>st</sup> – June 30<sup>th</sup>*

**HOUSE MOVING** – **License fee of \$125.00....AND**

- \$10,000 License Surety Bond

*License period – July 1<sup>st</sup> – June 30<sup>th</sup>*
