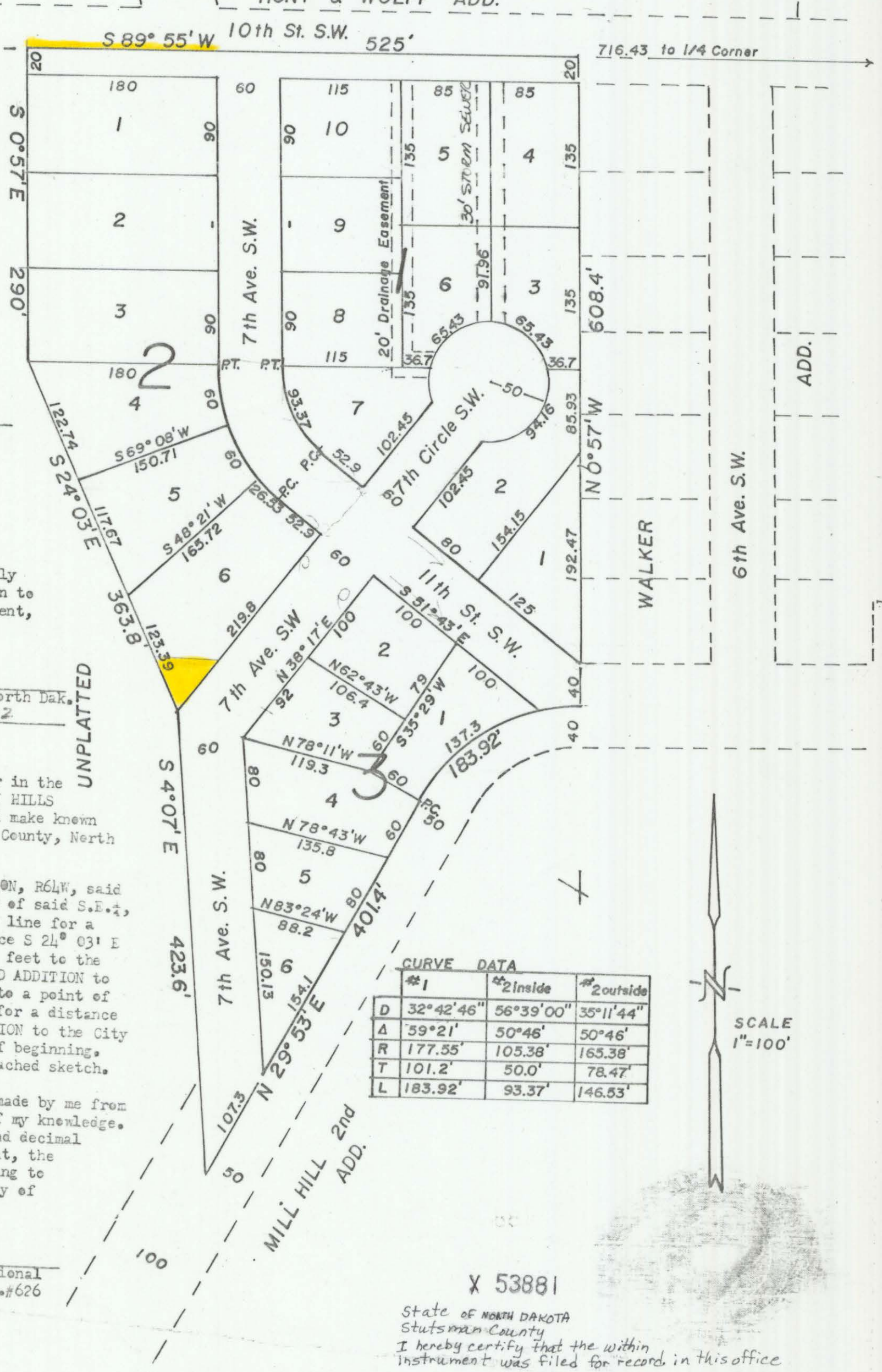

SURVEYORS CERTIFICATE:

I, Donald Wenas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of BEVERLY HILLS SECOND ADDITION to the City of Jamestown, North Dakota, do declare and make known that said plat is in the S.E. 1/4 of Section 35, T140N, R64W, in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at a point on the North line of the S.E. 1/4 of Section 35, T140N, R64W, said point being S 89° 55' W a distance of 716.43 feet from the N.E. corner of said S.E. 1/4, hence from this point of beginning continuing S 89° 55' W along said 1/4 line for a distance of 525 feet, hence S 0° 57' E for a distance of 290 feet, hence S 24° 03' E for a distance of 363.8 feet, hence S 4° 07' E for a distance of 423.6 feet to the centerline of what was platted as 7th Ave. S.W. in the MILL HILL SECOND ADDITION to the City of Jamestown, hence N 29° 53' E for a distance of 401.4 feet to a point of contact with a 32° 42' 46" curve, hence along said curve to the right for a distance of 183.92 feet, hence N 0° 57' W along the West line of WALKER'S ADDITION to the City of Jamestown, North Dakota for a distance of 608.4 feet to the point of beginning. Said parcel contains 8.24 acres, more or less, and is shown on the attached sketch.

I further certify that this plat of BEVERLY HILLS SECOND ADDITION was made by me from an actual survey thereof and that it is correct and true to the best of my knowledge.
