SURVEYORS CERTIFICATE:

I, Donald Wenaas, a Registered Professional Engineer and Land Surveyor in the state of North Dakota, and as surveyor of the attached plat of BEVERLY HILLS SEVENTH ADDITION to the City of Jamestown, North Dakota, do declare and make known that said plat is in the Southwest Quarter (SW 1/4) of Section Thirty Five (35) Township One Hundred and Forty North (T140N) of Range Sixty Four West (R64W) in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at the Northeast corner of Lot 1, Block 2, BEVERLY HILLS FOURTH ADDITION to the City of Jamestown, North Dakota, hence N 1° 12' E along the east line of said Beverly Hills Fourth Addition for a distance of 708 feet, hence S 88° 48' E along the South line of Lots 1 and 2, Block 1 said Beverly Hills Fourth Addition for a distance of 195 feet, hence N 1° 12' E along the East line of 13th Ave. SW for a distance of 168.8 feet, more or less to the North line of the SW 1/4 of said Section 35, hence N 89° 35' E along said 1/4 line for a distance of 130 feet, hence S 1° 12' W for a distance of 195 feet, hence S 19° 27' W for a distance of 79.67 feet, hence S 1° 12' W for a distance of 609.8 feet, hence N 88° 48' W for a distance of 300 feet to the point of beginning. said parcel contains 5.42 acres, more or less, and is shown on the attached sketch.

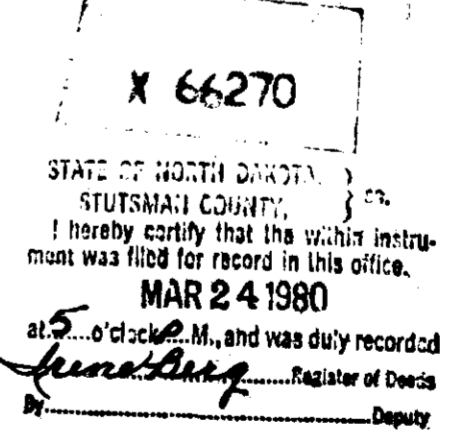
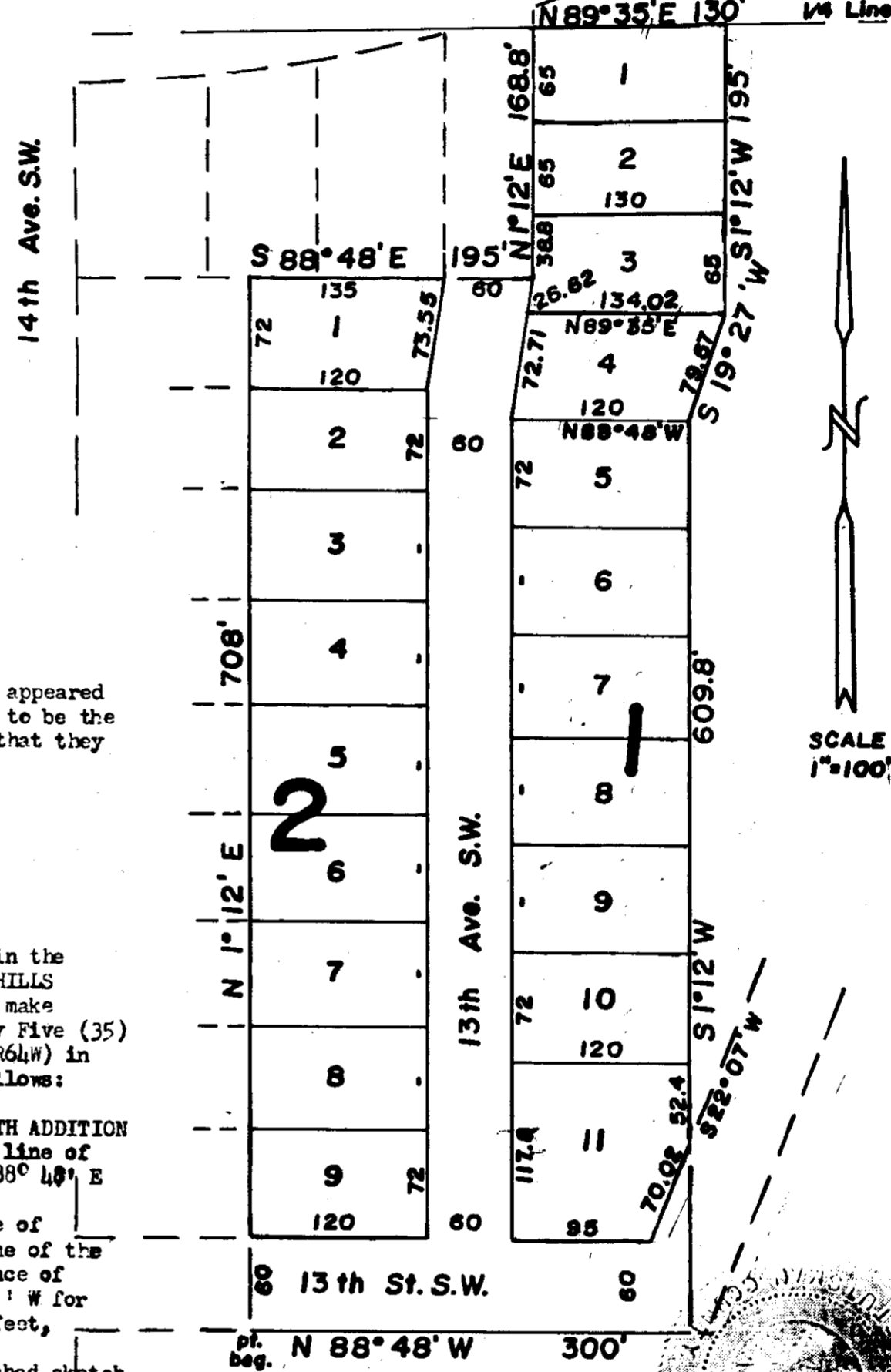
