THE TOWNSHIP OF CLEMENTSVILLE AS PLATTED HEREON IS SITUATED IN THE SOUTHWEST QUARTER (884) OF SECTION ELEVEN (11), TOWNSHIP ONE HUNDRED FORTY ONE (141), RANGE SIXTY TWO (62) WEST, AND IS FURTHER LOCATED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER (884) OF SAID SECTION ELEVEN (11), AND RUNNING THENCE NORTH ALONG THE WEST LINE OF SAID SOUTHWEST QUARTER (884) A DISTANCE OF ONE THOUSAND FIVE HUNDRED AND SEVENTY (1570) FEET, THENCE DUE EAST AT AN ANGLE OF NINETY DEGREES (90°) TO THE PREVIOUS DESCRIBED LINE, A DISTANCE OF TWO THOUSAND FORTY SIX AND EIGHT (2046.8) FEET, THENCE IN A SOUTHERLY DIRECTION AT AN ANGLE OF EIGHTY FOUR (84) DEGREES TO THE PREVIOUS DESCRIBED LINE, A DISTANCE OF ONE THOUSAND FIVE HUNDRED NINETY TWO (1592) FEET TO A POINT ON THE SOUTH LINE OF SAID SOUTHWEST QUARTER OF SECTION ELEVEN (11), THENCE RUN WEST ALONG THE SOUTH LINE OF SAID SOUTHWEST QUARTER (884) A DISTANCE OF ONE THOUSAND SEVEN HUNDRED FIFTY FIVE (1755) FEET TO THE POINT OF BEGINNING, SAID PIECE OF LAND CONTAINING SIXTY (60) ACRES MORE OR LESS, INCLUSIVE OF THE RIGHT OF WAY OF GREAT NORTHERN RAILROAD AS NOW LOCATED, ESTABLISHED AND BEARING TO AND ACROSS SAID SOUTHWEST QUARTER (884) OF SECTION ELEVEN (11), TOWNSHIP ONE HUNDRED FORTY ONE (141), RANGE SIXTY TWO (62).
