THE TOWNSHIP OF CLEMENTSVILLE AS PLATTED HEREBY IS SITUATED IN THE SOUTHEAST QUARTER (SE¹/₄) OF SECTION ELEVEN (11), TOWNSHIP ONE HUNDRED FORTY ONE (141), RANGE SIXTY TWO (62) WEST, AND IS FURTHER LOCATED AS FOLLOWS:
