### DECLARATION OF PLAT

Ted R. Anderberg, as owner and proprietor of the land hereinafter described, together with Donald Wenaas, Registered Professional Engineer and Land Surveyor, hereby declare and make known that said owner and proprietor recently caused to be laid out and platted and surveyed a plat of COUNTRY VIEW SUBDIVISION, Stutsman County, North Dakota; and this plat thereof which is attached hereto was made by said Donald Wenaas of Jamestown, North Dakota from an actual survey thereof in accordance with the Statutes of the State of North Dakota, in such case made and provided; a description of the situation and boundaries of said plat of COUNTRY VIEW SUBDIVISION being as follows:

Said tract is part of the Southeast Quarter (S.E. 1/4) of Section Nine (9) of Township One Hundred and Thirty Nine North, (T139N), Range Sixty Three West, (R63W) and is more particularly described as follows:

Beginning at the N.E. Corner of the S.E. 1/4 of Section 9, T139N, R63W, hence N 89 deg. 53 min. W along the East-West Quarter line for a distance of 550 feet, hence S 0 deg. 05 min. W a distance of 391 feet, hence S 89 deg. 53 min E a distance of 217 feet, hence S 0 deg, 05 min. W a distance of 1000 feet, hence S 89 deg. 53 min. E a distance of 333 feet to the East line of said Section 9, hence N 0 deg. 05 min. E along said section line a distance of 1391 feet to the point of beginning.

Said parcel contains 12.6 Acres, more or less, and is shown on the attached plat.

That the foregoing is a true and accurate description of the situation and boundaries of said plat of COUNTRY VIEW SUBDIVISION in the Southeast Quarter of Section 9, T139N, R63W, in Stutsman County, North Dakota.

All Streets, alleys and Avenues, and roadways, and all Lots are particularly described and set forth on the plat, with the widths, courses, lengths and breaths thereof, and the Lots being numbered in progressive numbers. The figures representing distances, lengths, and breaths, denote feet and decimal fractions thereof.

At the time of Surveying and laying out of said plat, the proprietor caused to be planted good and sufficient monuments conforming to the Statutes of the State of North Dakota covering the same, as shown on the attached plat.

And that said Donald Wenaas, as surveyor of said plat, further certifies that the plat of said COUNTRY VIEW SUBDIVISION was made by him from an actual survey thereof, and the same is in all respects correct and true to the best of his knowledge.

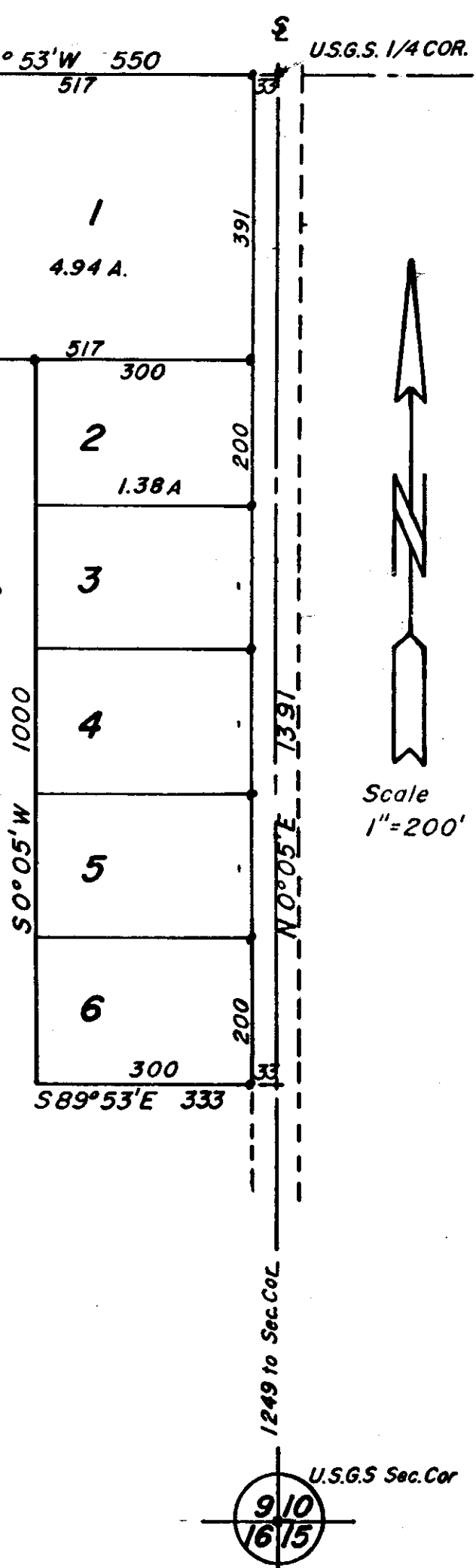
