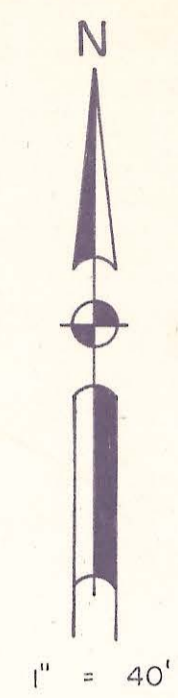
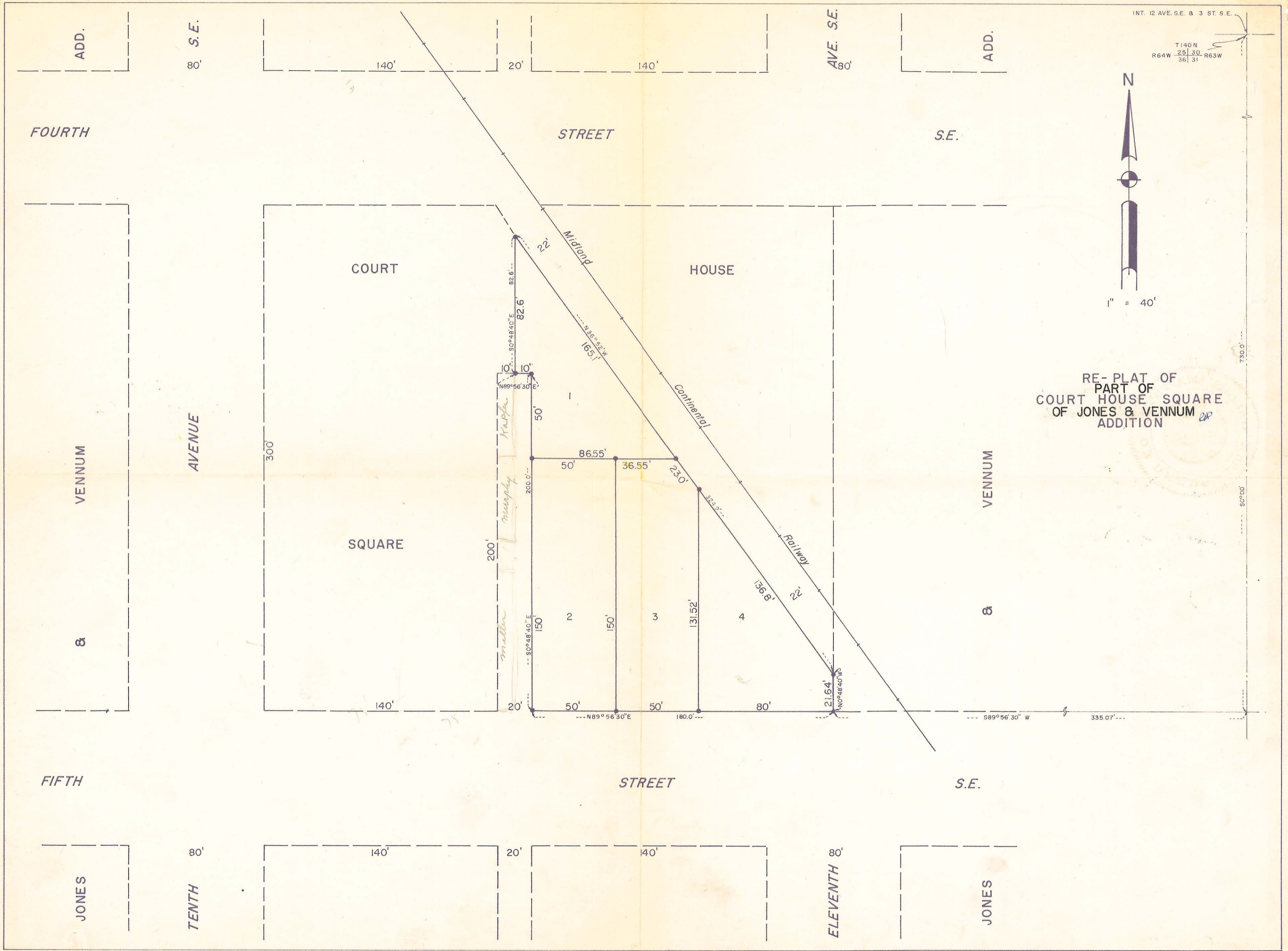

DECLARATION OF PLAT

Part of ^{OF JONES & VANNUM} Re-Plat of ^{END} Court House Square Addition to the City of Jamestown, North Dakota.

Alvin Berndt as owner and proprietor of the land hereinafter described, together with Ross Milne, North Central Engineers, Registered Land Surveyor, in the State of North Dakota, hereby declare and make known that said owner and proprietor recently caused to be replatted that tract of land formerly known as Court House Square ^{OF JONES & VANNUM} Addition to the City of Jamestown, North Dakota; and this plat thereof which is hereto attached was made by the said Ross Milne, in accordance with the statutes of the State of North Dakota and ordinances of the City of Jamestown, North Dakota, in such case, made and provided, a description of the situation and boundaries of said Re-Plat of ^{Part of} Court House Square ^{OF JONES & VANNUM} Addition being as follows:

That said plat is part of the Northwest One-Quarter of Section 36, T140N, R64W, in Stutsman County, North Dakota, and is more particularly described as follows:

Commencing at the section corner which is common to Sections 25 and 36, T140N, R64W, and Sections 30 and 31, T140N, R63W; thence S0°00' along the section line a distance of 730.0 feet to a point; thence S89°56'30"W a distance of 335.07 feet to the point of beginning; thence N0°48'40"W a distance of 21.64 feet to a point; thence N36°52'00"W a distance of 324.9 feet to a point; thence S0°48'40"E a distance of 82.6 feet to a point; thence N89°56'30"E a distance of 10.0 feet to a point; thence S0°48'40"E a distance of 200.0 feet to a point; thence N89°56'30"E a distance of 180.0 feet to the point of beginning.

Part of ^{OF JONES & VANNUM} That the foregoing is a true and accurate description of the situation and boundaries of said Re-Plat of ^{END} Court House Square Addition.

All the streets and avenues and alleys and all lots are particularly described and set forth on the plat, with the names, widths, courses, boundaries and extent thereof, and the lots being numbered in progressive numbers. The figures representing the distances, length and breadth, denote feet or decimals thereof. All streets and alleys are dedicated to the City of Jamestown in trust for the public use.

And the said Ross Milne as surveyor aforesaid, further certifies that the Re-Plat of said Addition was made by him from an actual survey thereof and the same is, to his knowledge and belief, correct and true.
