

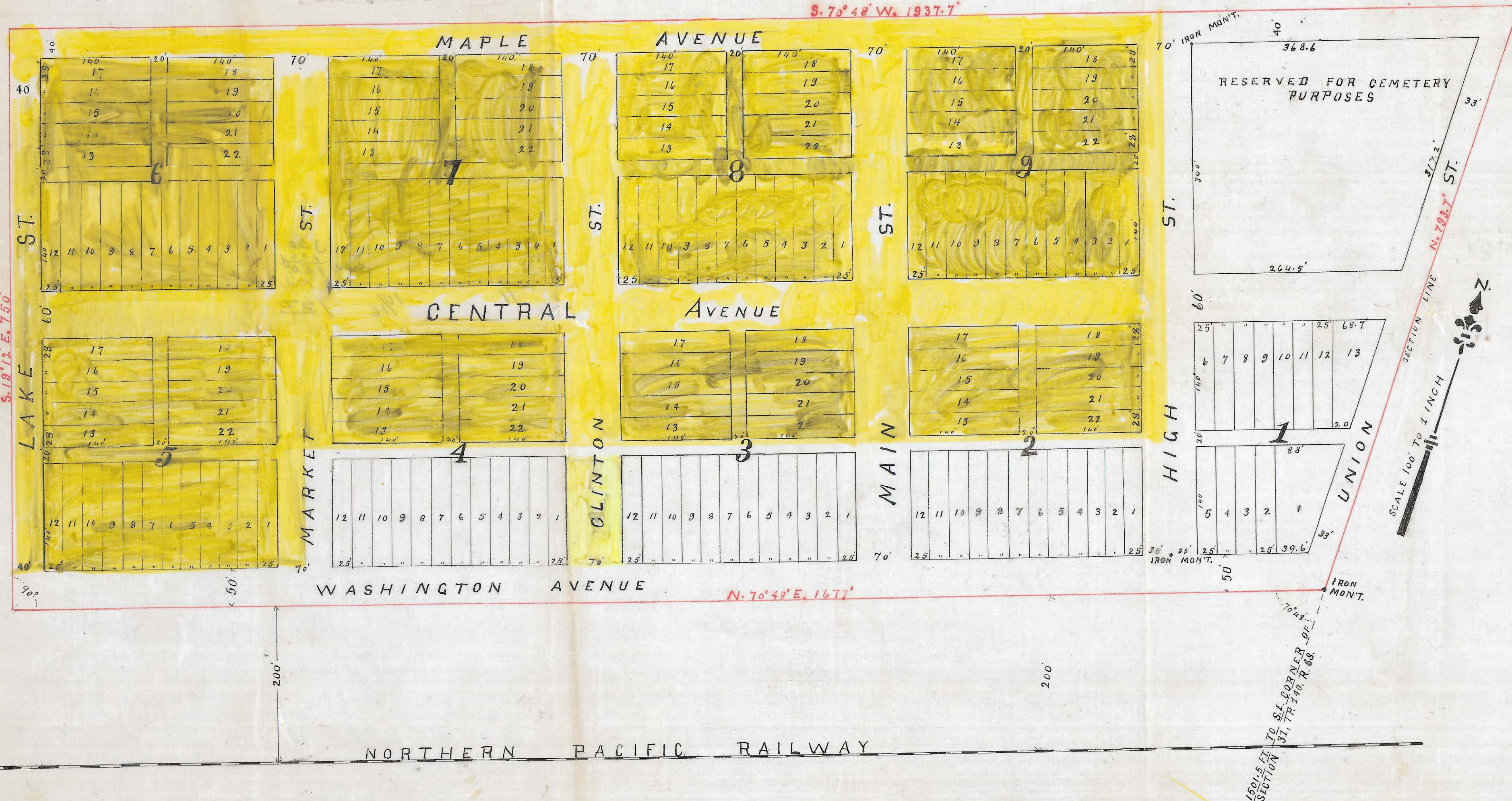
# DWYER'S ADDITION

Dwyer, her husband being owners and proprietors of a tract of land situated in the South East quarter of Section 31, Township 140 Range 68, in Stutsman County, North Dakota; more particularly described as follows: Commencing at a point on the east line of said section 31, T. 140 R. 68, 1501.5 feet north of the South east corner of said section 31 T. 140 R. 68; thence north on section line 793.7 feet; thence south 70° 48' West 1937.7 feet; thence south 19° 12' East 750 feet; thence north 70° 48' East 1677 feet to point of beginning containing 31.11 acres; have caused the same to be surveyed and platted in the manner shown on the annexed map as Dwyer's Addition to Medina, N. Dak. and do hereby donate and dedicate to the public use forever all the streets avenues and alleys thereon shown.
