### DECLARATION OF PLAT:

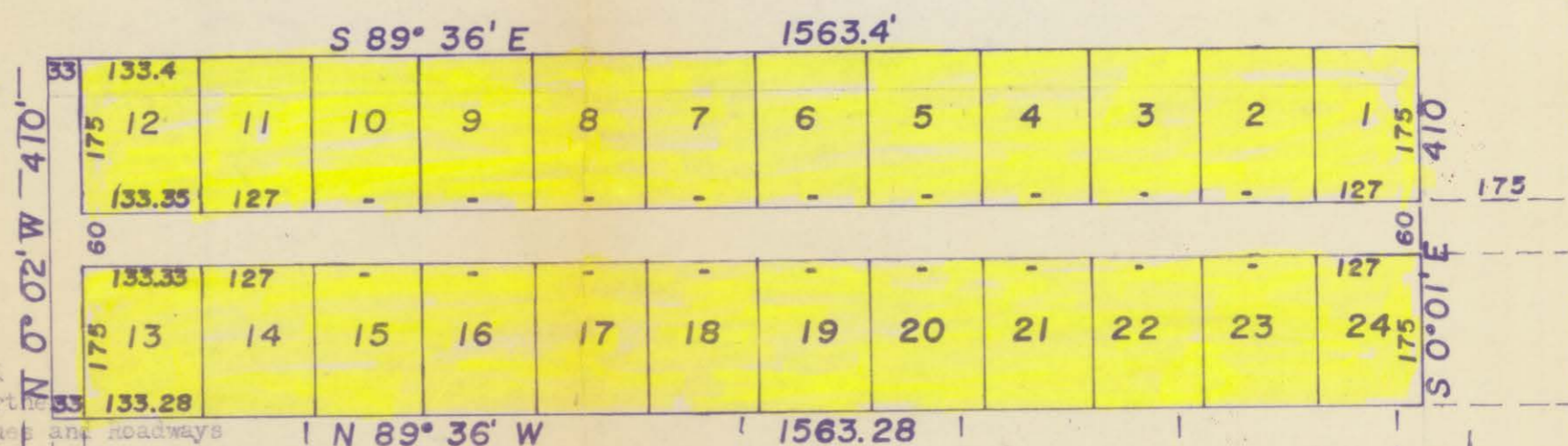

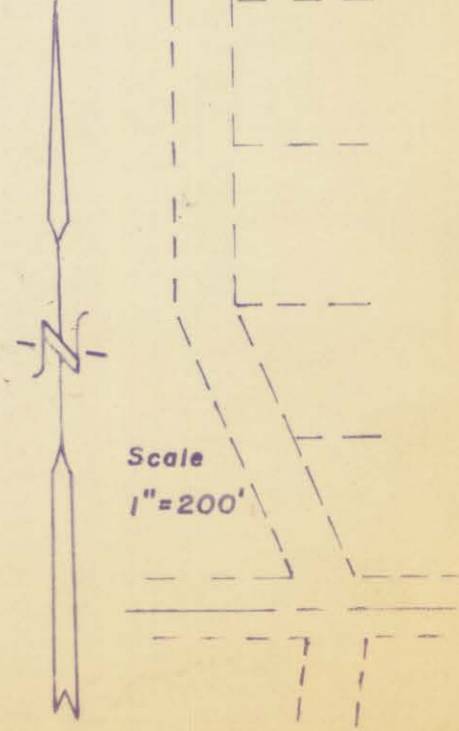

### Surveyors Certificate:

I, Donald Wenaas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of GLACIER POINT SUBDIVISION, do declare and make known that said plat is in the S.E. 1/4 of Section 11, T140N, R64W in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at a point 660 feet N 0° 02' W along the West line of the S.E. 1/4 of Section 11, T140N, R64W from the S.W. corner of said S.E. 1/4, hence continuing N 0° 02' W along the said West line for a distance of 110 feet, hence S 89° 36' E for a distance of 1563.4 feet, hence S 0° 01' E for a distance of 110 feet to the North line of MIDWAY ESTATES 2/ND, hence N 89° 36' W along said North line for a distance of 1563.28 feet to the point of beginning. Said parcel contains 14.7 acres, more or less, and is shown on the attached sketch.
