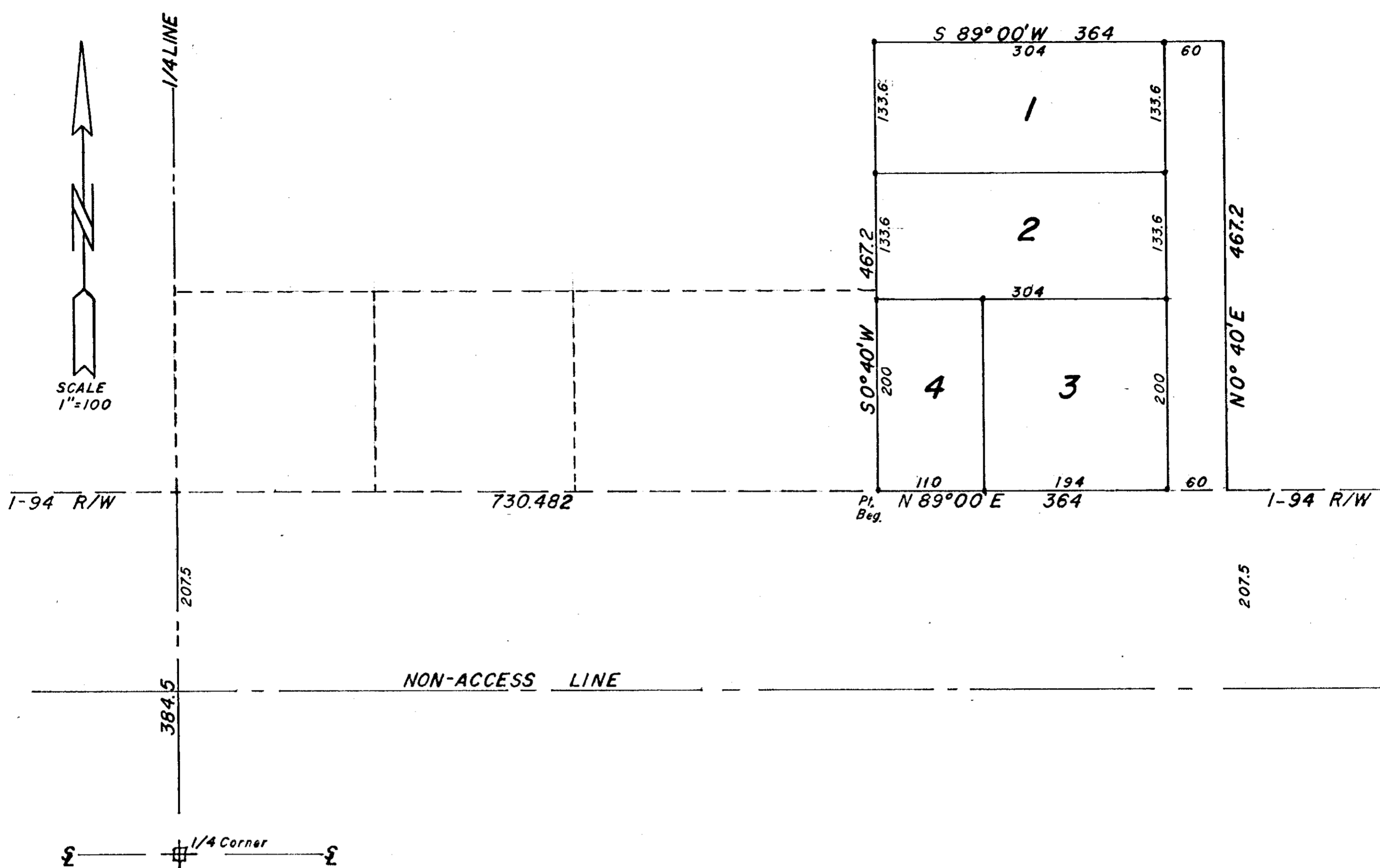

DECLARATION OF PLAT

Elizabeth Aus, an unmarried widow, as owner and proprietor, and Arvel Glinz, as holder of a contract for deed, together with Donald Wenaas, Registered Professional Engineer and Land Surveyor, hereby declare and make known that said owners and proprietors recently caused to be laid out and platted and surveyed, a plat of GLINZ ESTATES, Stutsman County, North Dakota; and this plat thereof which is attached hereto was made by said Donald Wenaas of Jamestown, North Dakota, from an actual survey thereof in accordance with the Statutes of the State of North Dakota, in such case made and provided; a description of the situation and boundaries of said plat of GLINZ ESTATES being as follows:

Said tract is a part of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirtythree (33), Township One Hundred and Forty North (T140N), Range Sixtyfour West (R64W), in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at the Southwest corner of the Southeast Quarter of Section 33, T 140N, R64W, hence N 0° 40' E along the West line of said SE $\frac{1}{4}$ for a distance of 384.5 feet, hence N 89° 00' E, parallel to the South line of said SE $\frac{1}{4}$ for a distance of 730.482 feet to the true point of beginning; hence continuing N 89° 00' E for a distance of 364 feet, hence N 0° 40' E for a distance of 467.2 feet, hence S 89° 00' W for a distance of 364 feet, hence S 0° 40' W for a distance of 467.2 feet to the point of beginning.

Said tract contains 3.9 acres, more or less, and is shown on the attached plat.

That the foregoing is a true and accurate description of the situation and boundaries of said plat of GLINZ ESTATES in Stutsman County, North Dakota.

All Streets, Avenues, and alleys, and all Lots are particularly described and set forth on the plat, with the widths, courses, boundaries, and extents thereof, the lots being numbered in progressive numbers. The figures representing distances, lengths, and bearings denote feet and decimal fractions thereof.

At the time of surveying and laying out of said subdivision, the proprietors caused to be planted good and sufficient monuments conforming to the Statutes of the State of North Dakota covering the same, as shown on the attached plat.

And that said Donald Wenaas, as surveyor of said plat, further certifies that the plat of GLINZ ESTATES was made by him from an actual survey thereof, and the same is in all respects correct and true to the best of his knowledge.
