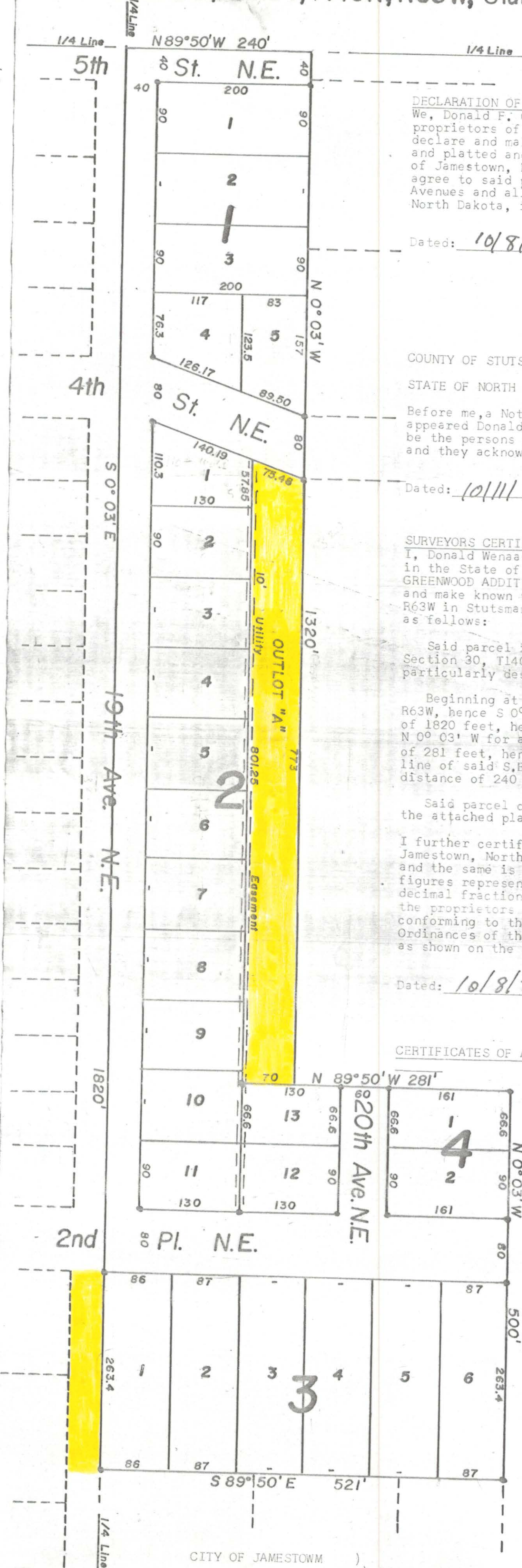

SURVEYORS CERTIFICATE:
 I, Donald Wenasas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of GREENWOOD ADDITION to the City of Jamestown, North Dakota, do declare and make known that said plat is in Tract "A", S.E. 1/4, Section 30, T140N, R63W in Stutsman County, N. Dak. and is more particularly described as follows:

Said parcel is what has been known as Tract "A" of the S.E. 1/4 of Section 30, T140N, R63W, in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at the NorthWest corner of the S.E. 1/4 of Section 30, T140N, R63W, hence S 0° 03' E along the West line of said S.E. 1/4 for a distance of 1820 feet, hence S 89° 50' E for a distance of 521 feet, hence N 0° 03' W for a distance of 500 feet, hence 89° 50' W for a distance of 281 feet, hence N 0° 03' W for a distance of 1320 feet to the North line of said S.E. 1/4, hence N 89° 50' W along said North line for a distance of 240 feet to the point of beginning.

Said parcel contains 13.25 Acres, more or less, and is shown on the attached plat.
