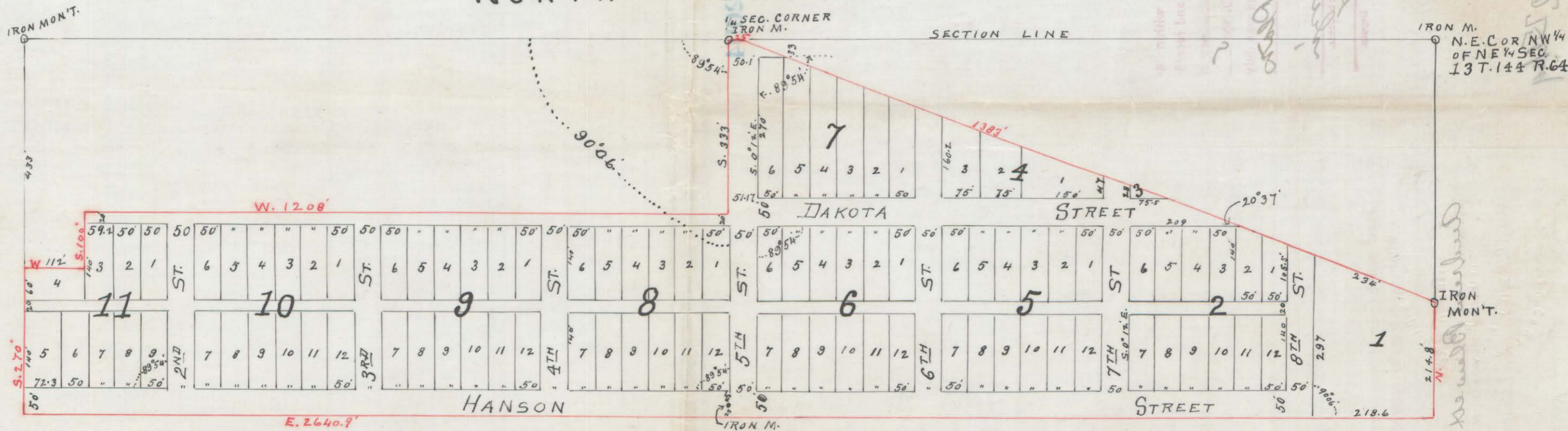


# HANSON'S ADDITION TO KENSAL

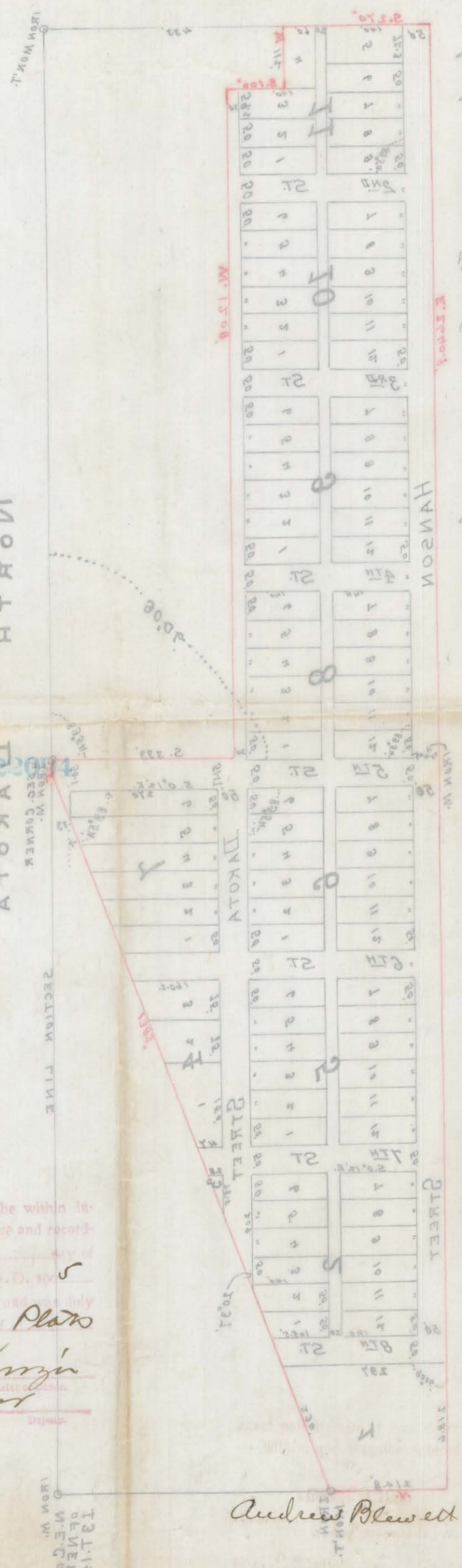
