

HOGGARTH BROTHERS SUBDIVISION WITHIN GOVERNMENT LOTS 2 AND 3, SEI/4SI/2NWI/4, SI/2NEI/4, EI/2SWI/4 AND WI/2SEI/4

> SECTION I, TI40N, R64W STUTSMAN COUNTY, NORTH DAKOTA

The parties set forth hereon as Owners and Proprietors of the land hereinafter described together with LeRoy H. Kautz, Interstate Engineering, Inc. a Registered Land Surveyor in the State of North Dakota; hereby declare and make known that said Owners and Proprietors recently caused to be platted a portion of land within Sectin One (I), Township 140 North, Range 64 West of the Fifth Principal Meridian in Stutsman County, North Dakota hereinafter referred to as "Hoggarth Brothers Subdivision". The plat thereof which is hereby attached was made by said LeRoy H. Kautz in accordance with the statutes of the State of North Dakota and the Township of Bloom, Stutsman County, North Dakota, in such case made and provided a description of the situation and boundaries of said plat being as follows:

> DESCRIPTION OF PLATTED AREA HOGGARTH BROTHERS SUBDIVISION IN STUTSMAN COUNTY, NORTH DAKOTA

A tract of land located within Government Lots 2 and 3, SEI/4SI/2NWI/4, SI/2 NEI/4, EI/2SWI/4 and the WI/2SEI/4 of Section I, TI40N, R64W of the Fifth Principal Meridian, Stutsman County, North Dakota more particularly described as follows:

of beginning. Said tract of land contains 107.02 acres more or less.

Bearings for the plat and description were deflected from a 1957 G.L.O. bearing of N 0°08'00" W along the east line of said Section I.

The tract of land is particularly described and set forth on the plat with the names, widths, courses, boundaries and extent thereof. The figures representing the distances, length and breadth denote feet and decimals thereof. The right-of-way for Hoggarth Drive as shown on the plat is dedicated for the public use and the easements are as shown on the plat.
