

PLAT OF ISLAND PARK ADDITION

STUTSMAN COUNTY, NORTH DAKOTA

The parties set forth hereon as owners and proprietors of the land hereinafter described together with Johnny Klingenberg, North Central Consultants, Ltd., a Registered Professional Engineer and Land Surveyor in the State of North Dakota; hereby declare and make known that said owners and proprietors recently caused to be platted Island Park Addition of the S.W. \frac{1}{4}, Section 24 TI40N, R64W. The plat thereof which is hereby attached was made by said Johnny Klingenberg in accordance with the statutes of the State of North Dakota and ordinances of the City of Jamestown, North Dakota, in such case made and provided a description of the situation and boundaries of said plat being as follows:

DESCRIPTION OF PLATTED AREA OF ISLAND PARK ADDITION


IN STUTSMAN COUNTY, NORTH DAKOTA

A parcel of land in the Southwest One Quarter of Section 24, Township 140 North, Range 64 West, 5th Principal Meridian, North Dakota, described as follows:

Commencing at the Southwest corner of Section 24, Township 140 North, Range 64 West, 5th Principle Meridian; thence North 697.83 feet along the West Boundary of said Section 24, thence South 89°56′00″ East 357 feet to the point of beginning; thence continuing South 89°56′00″ east 506.76 feet to a point on the west edge of the James River, thence following along a survey line for the next seven consecutive courses which follow the brush meander line of the James River. Said survey line is used for the purpose of a closed parcel and the true East Boundary of this parcel follows the waters edge of the James River described and shown more accurately by accompanying plat, North 8°36′29″ East 306.06 feet; thence North 29°25′18″ East 294.87 feet; thence North 0°24′55″ West 440.42 feet; thence North 22°33′52″ West 242.29 feet; thence North 23°11′21″ East 337.79 feet; North 10°01′53″ West 301.17 feet; thence North 1°09′20″ West 149.97 feet to a point on the North boundary of the said Southwest One Quarter; thence North 8°56′49″ West 276.82 feet along said North Boundary of the Southwest One Quarter of Section 24 to a point on the East edge of a un-named body of water; thence following along a survey line for the next ten consecutive courses which follow the brush meander line of said un-named body of water. Said survey line is used for the purpose of a closed parcel and the true West Boundary of this parcel follows the waters edge of said un-named body of water; described and shown more accurately by accompanying plat, South 16°18′26″ West 147.87 feet; thence South 2°41′35″ West 535.27 feet; thence South 13°10′40″ West 167.25 feet; thence South 10°43′52″ West 73.16 feet; thence South 15° 51′27″ West 535.27 feet; thence South 13°0′40″ West 167.25 feet; thence North 77°46′06″ West 73.16 feet; thence North 5°41′48″ East 171.25 feet to the North Boundary of Government Lot 2 of said section 24; thence West 0°00′00″ 23 feet along said North Boundary of said Government Lot 2 to the East Boundary of 3rd Avenue Northwest; thence

All the streets and avenues and alleys, and all blocks and all lots are particularly described and set forth on the plat, with the names, widths, courses, boundaries and extent thereof, and the block and lots being numbered in progressive numbers. The figures representing the distances, length and breadth, denote feet or decimals thereof. All streets and alleys are dedicated to the City of Jamestown in trust for public use.
