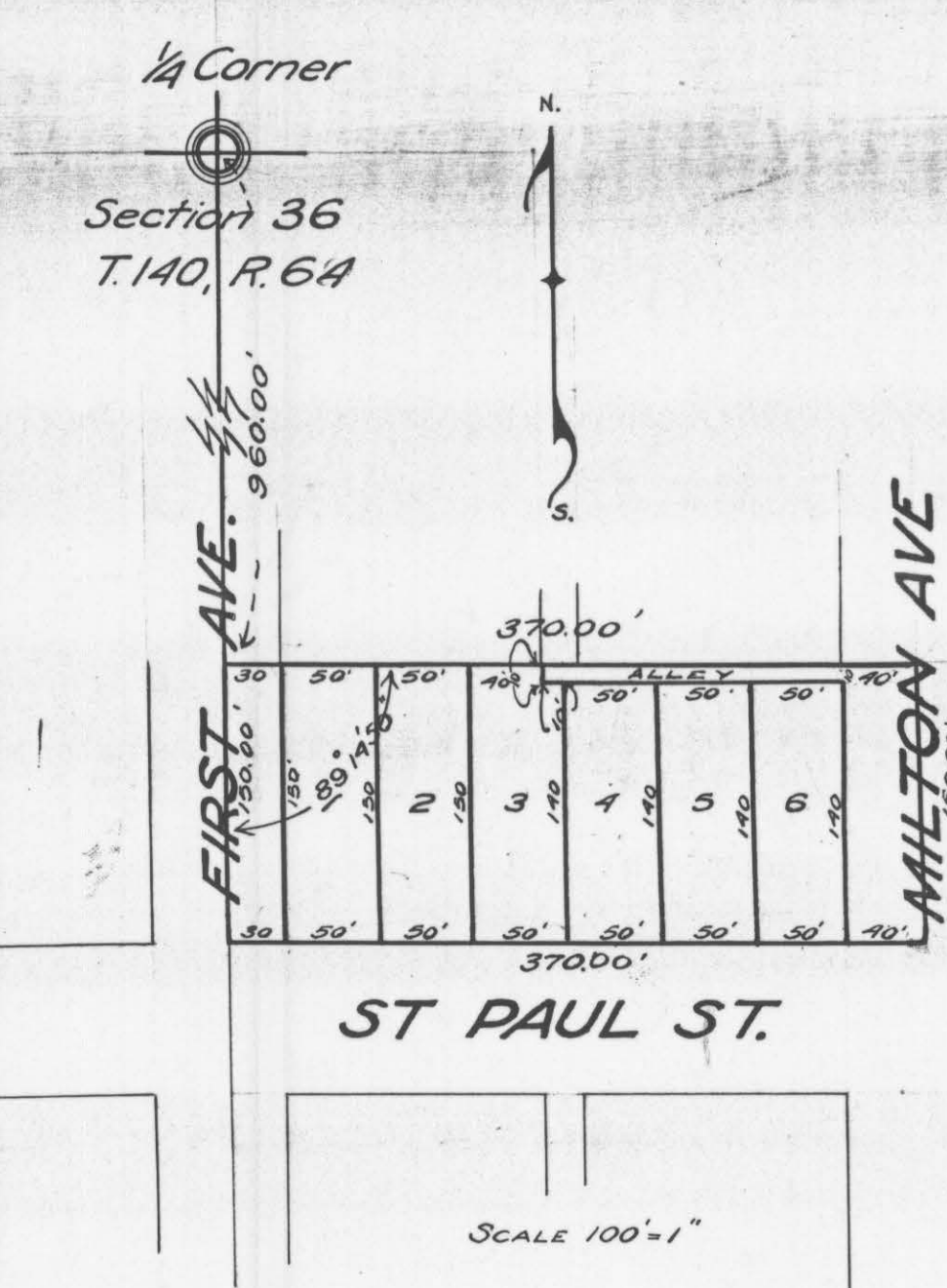


ORIGINAL PLAT OF THE J. J. NIERLING ADDITION JAMESTOWN, NORTH DAKOTA.

DECLARATION OF PLAT:

The J. J. Nierling Addition to the City of Jamestown, Stutsman County, North Dakota, comprises part of the east half of the north-east quarter of Section 36, Township 140 North, Range 64 West, and is more particularly described as follows,-

Beginning at a point on the north and south half section line of Section 36, 140-64, 960.00 feet south of the north quarter section corner thereof, thence S. 89° 14' 50" E., 370.00 feet, thence South 150.00 feet, thence N. 69° 14' 50" W., 370.00 feet, thence North 150.00 feet to point of beginning.

J. J. Nierling and Una M., his wife, Albert L. Miller & Mabel D., his wife, William Todd and Sara, his wife, J. C. Long, single, and Anna M. McGinnis, widow, owners and proprietors, together with John M. Hansen, Surveyor, hereby declare and make known that the said owners and proprietors, caused to be laid out and platted during the month of November, 1917, and this plat thereof to be made by the said John M. Hansen, Surveyor, according to the statutes in such case provided. The owners and proprietors do hereby dedicate all the streets, avenues and alleys described on the attached plat to and for the public use forever, and together with the said Surveyor do hereby certify that the foregoing is a true and accurate description of the situation and boundaries of the said J. J. Nierling Addition.

All the streets and avenues and all lots are particularly described and set forth on the plat with names, widths, boundaries and extent thereof. The figures representing distance, length or breadth, denote feet and decimals thereof. The said John M. Hansen, Surveyor, further certifies that the plat of said Addition was made by him from actual survey thereof and that the same is in all respects correct and true.
