A tract of land located within Government Lot 5 of Section 36, T142N, R63W of the Fifth Principal Meridian in the City of Spiritwood Lake, Stutsman County, North Dakota, said tract of land being bounded on the northerly side by the north line of said Section 36, bounded on the easterly side by an existing survey of Parcels A and B of Document Number X106324 and Spiritwood Lake, bounded on the southerly side by the north line of Lot C, Document Number X4625, and bounded on the westerly side by the west line of said Government Lot 5; said tract of land being more particularly described as follows:

COMMENCING at the North Quarter Corner of said Section 36, also being the POINT OF BEGINNING;

THENCE S89°15'00"E on the north line of said Section 36 a distance of 839.07 feet;

THENCE S12°23'16"E a distance of 655.80 feet to the northeast corner of Parcel A of Document Number X106324; THENCE S31°59'09"W along the north line of Parcel A of Document Number X106324 a distance of 96.53 feet to the northwest corner of said Parcel A;

THENCE S40°55'50"E along the west line of Parcel A of Document Number X106324 a distance of 139.10 feet to the southeast corner of said Parcel A;

THENCE S12°21'00"E a distance of 56.08 feet to the northwest corner of Parcel B of Document Number X106324, also being a point on a meander line of Spiritwood Lake;

THENCE S42°07'36"W along said meander line of Spiritwood Lake a distance of 92.27 feet; THENCE S37°59'25"E along said meander line of Spiritwood Lake a distance of 249.59 feet to a point on the north line of Lot C of Document Number X4625;

THENCE N89°18'53"W along the north line of said Lot C a distance of 995.38 feet to the northwest corner of said Lot C and the west line of said Government Lot 5; THENCE NO0°10'20"E on the west line of said Government Lot 5 a distance of 1107.85 feet to the point of beginning and the end of this description.

Subject to existing easements of record and particularly subject to a 40 foot water pipeline easement and a 40 foot easement for ingress/egress, utility and drainage purposes as shown on the plat hereof. Outlot 1 of said plat is intended to be non buildable (no primary dwelling), with a portion being used for a private drive and private access to Spiritwood Lake. The interest in Outlot 1 will be determined and assigned by a separate document at the time of conveyance.

Said tract of land contains 23.94 acres more or less and includes all that land lying between the meander line and the approximate ordinary high water mark of Spiritwood Lake. Said tract of land contains 22.49 acres more or less excluding those lands dedicated to the public for roadway purposes.


