

# Jamestown Hospital Healthcare Campus 2nd Addition

## Replat Of Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition To The City Of Jamestown, Stutsman County, North Dakota

The parties set forth hereon as owners and proprietors of the land hereinafter described, together with Gregory J. Rich, Interstate Engineering, Inc., a Registered Land Surveyor in the State of North Dakota, hereby declare and make known that said owners and proprietors recently caused to be re-platted Lot 2, Block 1, JAMESTOWN HOSPITAL HEALTHCARE CAMPUS ADDITION (Document #X188143) within the N1/2 of Section 3, T139N, R64W of the Fifth Principal Meridian, within the City of Jamestown, Stutsman County, North Dakota, hereinafter known as "JAMESTOWN HOSPITAL HEALTHCARE CAMPUS 2nd ADDITION". The plat thereof which is hereby attached was made by said Gregory J. Rich, in accordance with the statutes of the State of North Dakota and the ordinances of the City of Jamestown, North Dakota, in such case, made and provided a description of the situation and boundaries of said plat being as follows:.

#### PLAT BOUNDARY DESCRIPTION

A tract of land located within the N1/2 of Section 3, T139N, R64W of the Fifth Principal Meridian, City of Jamestown, Stutsman County, North Dakota more particularly described as follows:

Commencing at the southwest corner of said Lot 2, Block 1 Jamestown Hospital Healthcare Campus Addition, also being the point of beginning; thence N0°09'34"E, along the west line of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition a distance of 1,310.69 feet to the northwest corner of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition, also being a point on the southerly right of way line of U.S. Interstate 94; thence S89°11'15"E, along the north line of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition and said southerly right of way line a distance of 448.13 feet to the beginning of a non-tangent curve to the right; thence 690.55 feet along the arc of said curve having a radius of 5629.65 feet whose chord bears S79°11'25"E 690.12 feet; thence S75°40'34"E along the north line of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition and the southerly right of way line of U.S. Interstate 94 a distance of 411.22 feet to the northeast corner of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition; thence S0"15'43"W, along the east line of said Lot 2, Block 1, Jamestown Hospital Healthcare Compus Addition a distance of 1,095.05 feet to the southeast corner of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition; thence N89°10'38"W along the south line of said Lot 2, Block 1, Jamestown Hospital Healthcare Campus Addition a distance of 1,523.19 feet to the point of beginning and the end of this description.


