Kelly and Fullers second addition to Jamestown is situated in the ~~south~~ <sup>W</sup>  $\frac{1}{2}$  of Section No 26 Town 140 Range 1064 and is more particularly described as follows. Commencing at the south east corner of sec 26 thence westerly following the section line on the south side of sec 26 for a distance of 2932.4 feet. Thence North  $1^{\circ} 12'$  west for a distance of 683.3 to a point 200 ft south of the centre line of the N.P.R.R. Thence  $N 88^{\circ} 48' E$  following a line parallel to + 200 ft distant from the centre line of the N.P.R.R. for a distance of 2944 feet to a point on the east line of sec 26. Thence southerly following the east line of sec 26 for a distance of 788.98 feet to the place of beginning. Main St is 40 ft wide & is parallel to the N.P.R.R. Second St is 60 ft wide and is parallel to Main St First St is 33 ft wide and parallel to the section line on the south side of sec 26. Eighth St is 33 ft wide and parallel to the section line on the east side of sec 26. All the other streets are at right angles to Main St and are 60 ft wide except Pearl St which is 30 ft wide. The dimensions of the lots are shown on the plat at or near the boundaries of the several lots in feet and decimals. The numbers of the lots are shown on the plat at or near centres of the several lots. Stone monuments are placed where they are shown on the plat
