
KRAPP FIRST ADDITION

A REPLAT OF PART OF THE NEI/4NEI/4 AND PART OF GOVERNMENT LOT THREE OF SECTION 31 AND PART OF GOVERNMENT LOTS ONE AND SIX OF SECTION 32, TI42N, R62W OF THE FIFTH PRINCIPAL MERIDIAN, CITY OF SPIRITWOOD LAKE, STUTSMAN COUNTY, NORTH DAKOTA

A replat of part of the NEI/4NEI/4 and part of Government Lot Three of Section 31 and part of Government Lots One and Six of Section 32, TI42N, R62W of the Fifth Principal Meridian, City of Spiritwood Lake, Stutsman County, North Dakota.

DECLARATION OF PLAT

The parties set forth hereon as owners and proprietors of the land hereinafter described together with James H. Fletchall, Interstate Engineering, Inc., a Registered Professional Land Surveyor in the State of North Dakota, hereby declare and make known that said owners and proprietors recently caused to be replatted part of the NEI/4NEI/4 and part of Government Lot Three of Section 31 and part of Government Lots One and Six of Section 32, City of Spiritwood Lake, North Dakota, the plat thereof which is hereby attached was made by said James H. Fletchall in accordance with the statutes of the State of North Dakota and ordinances of the City of Spiritwood Lake, North Dakota, in such case made and provided a description of the situation and boundaries of said replat being as follows:

> DESCRIPTION OF REPLATTED AREA KRAPP FIRST ADDITION

Lot I, Block 1

A tract of land located within part of the NEI/4NEI/4 and part of Government Lot Three, Section 31, TI42N, R62W of the Fifth Principal Meridian, City of Spiritwood Lake, Stutsman County, North Dakota, being more particularly described as follows:

Commencing at the section corner common to Sections 29, 30, 31 and 32; thence SO°18'18"E (assumed bearing) along the east line of said Section 31, 1255.73 feet to the point of beginning; thence continuing SO°18'18"E, along said section line, 995.70 feet to a point on the NE share of Spiritwood Lake; thence N71°24'21"W, along said shoreline, 34.56 feet; thence N29°12'55"W, along said shoreline, 557.16 feet to the SE corner of Indian Springs Second Addition; thence N23°20'57"E, along the easterly line of said Indian Springs Second Addition, 371.00 feet; thence N70°37'07"W, along the northeasterly line of said Indian Springs Second Addition, 180.33 feet; thence NO°21'15"E, 52.89 feet to a point on the northerly line of Spiritwood Avenue; thence S70°37'07"E, along said northerly line, 121.49 feet; thence N67°37'49" along said northerly line, 224.34 feet to the point of beginning. Said tract of land contains 4.33 acres more or less.

A tract of land located within part of Government Lots One and Six of Section 32, TI42N, R62W of the Fifth Principal Meridian, City of Spiritwood Lake, Stutsman County, North Dakota, being more particularly described as follows.

Commencing at the section corner common to Sections 29, 30, 31 and 32; thence SO°18'18"E (assumed bearing) along the west line of said Section 32. 1255.73 feet to the point of beginning; thence N67°37′49″E, along the northerly line of Spiritwood Avenue, 52.35 feet; thence N73°09′16″E, along said northerly line, 187.36 feet; thence N84°25'12"E, 94.39 feet to a point on the easterly line of East County Lake Road; thence, along a 10°03'00" curve to the left, along said easterly line, an arc length of 316.45 feet, said curve having a chord bearing of \$21°28'54"E and a chord length of 312.41 feet; thence S37°23'00"E, along said easterly line, 344.06 feet; thence S34°25'38"E, along said easterly line, 305.02 feet; thence S55°34'22W, at the location of the culverts under said East County Lake Road, 66.00 feet to a point on the westerly line of said East County Lake Road; thence N34°25'38"W. along said westerly line 229.34 feet; thence S55°34'22"W, along the shoreline of Spiritwood Lake, 75.57 feet; thence S52°06'32"W, along said shoreline, 156.67 feet; thence \$9°38'31"W, along said shoreline, 165.26 feet; thence \$57°35'12"W, along said shoreline, 136.41 feet; thence \$68°18'24"W, along said shoreline, 165.57 feet; thence N89°04'31"W, along said shoreline, 87.36 feet; thence N71°24'21"W, along said shoreline, 61.23 feet to a point on the west line of said Section 32; thence NO°18'18"W, along said west line, 995.70 feet to the point of beginning.
