

LIECHTY HOMES ADDITION A REPLAT OF PART OF BLOCK 4, SOUTHWOOD ADDITION WITHIN NE1/4, DF SECTION 2, T139N, R64W CITY DF JAMESTOWN, STUTSMAN COUNTY, NORTH DAKOTA

The parties set forth hereon as owners and proprietors of the land hereinafter described together with James H. Fletchall, Interstate Engineering, Inc., a Registered Land Surveyor in the State of North Dakota, hereby declare and make known that said owner and proprietor recently caused to be platted a tract of land within the NE1/4, of Section 2, Township 139 North, Range 64 West of the Fifth Principal Meridian in Stutsman County, North Dakota, hereinafter referred to as 'Liechty Homes Addition'. The plat thereof which is hereby attached was made by said James H. A tract of land located within the NE1/4, Section 2, T139N, R64W of the Fifth Principal Meridian, within the City of Jamestown, Stutsman County, North Dakota, being more particularly described as follows:

Beginning at the southeast corner of Lot 10, Block 4, Southwood Addition to the City of Jamestown; thence N1°08'33'E along the east lot line of said Lot 10, for a distance of 190.00 feet to a point; thence N88°51'27'W for a distance of 400.00 feet to point; thence N1°08'33'E along the east lot line of Lot 3, Block 4, Southwood Addition and its prolongation 258.33 feet to a point; thence S 89°57'33' W for a distance of 300.06 feet to a point; thence N1°08'33'E for a distance of 77.02 feet to a point; thence N89°57'33'E parallel to the north line of the NE, of said Section 2 for a distance of 1,064.74 feet to a point; thence S0°26'54'E parallel to the east line of the NE1/4 of said Section 2 for a distance of 541.35 feet to a point; thence N88°51'27'W along the north line of 18th Street SW for a distance of 379.54 feet, plus or minus, to the point of beginning.
