
A Plat of McGinnis's 3rd Addition to the City of Jamestown, No. Dak.



BE IT KNOWN that I, Mary DeNault Grettenberg, owner and proprietor of certain land in the Part of SEt lying North of Northern Pacific Railway and east of center line of Lawrence Ave. and South of land to Jamestown College, Section 25, Twp. 140 North, Range 64

West, to be hereafter know as the McGinnis 3rd Addition, have caused the real estate described in the certificate herein, to be platted as an Addition to the Townsite of Jamestown, North Dakota. That McGinnis 3rd Addition consists of Lots 1 to 3 inclusive in Part of Block 1, all lots,

## Surveyor's Certificate.

McGinnis 3rd Addition is described as follows; Beginning \* at a point 790 feet east and 200 feet north of the monuments on Front Street and Pittsburgh Avenue as now located, thence north for a distance of 150 feet, thence east at an angle of 90° with the last described line a distance of 150 feet, thence south at an angle of 90° with the last described line a distance of 150 feet, thence west at an angle of 90° with the last described line a distance of 150 feet to the point of beginning. Tract contains 0.5 acres more or less.

All the dimensions are shown in feet and tenths of feet. All Streets are 80 feet in width. All Lots are 50 feet wide and 150 feet long as shown on the Plat. Iron pipes are placed at the corners of all Lots.
