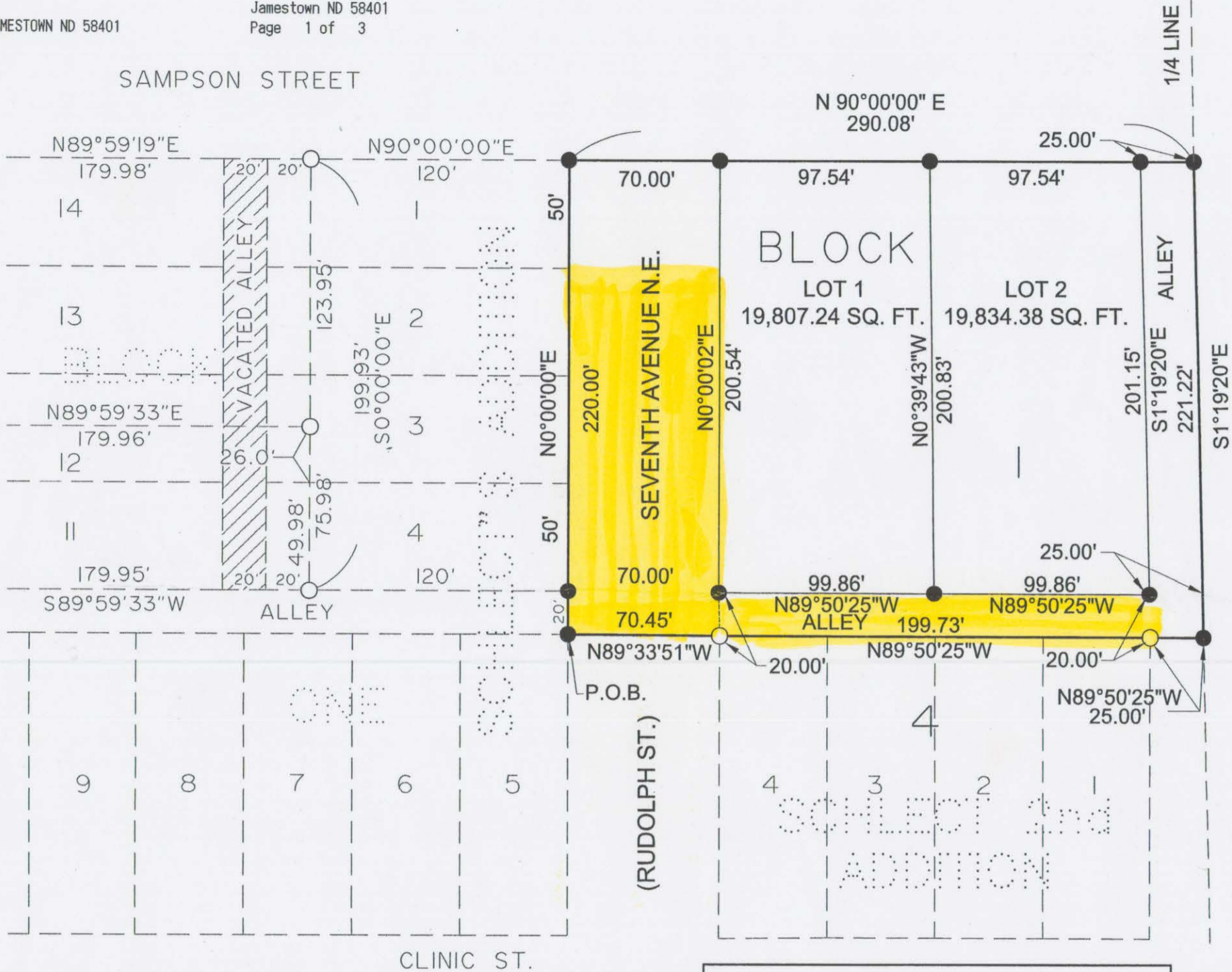

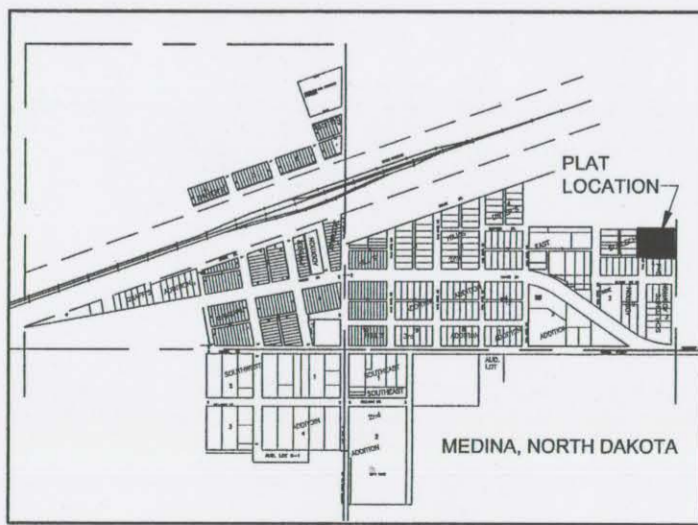


LEGEND

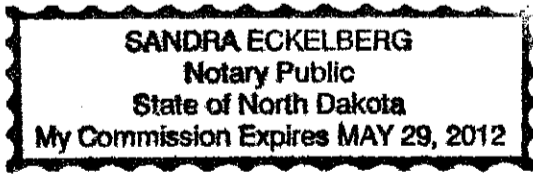
