This is to certify that I have carefully surveyed and accurately platted that part of the North West Quarter of Section Twenty-six, Township One Hundred and Thirty-seven and Range Sixty-nine, County of Stutsman, State of North Dakota, as follows:

Commencing at a point 441-9/10 feet North 82°05' East of a point 656-4/10 feet, south of the North West corner of the North West Quarter of said section twenty-six, thence running north 82°05' East 1360 feet, thence southerly at right angles 750 feet, to a point 150 feet northerly from the center line of the main track of the Northern Pacific Railway Company, as now located across said Quarter Section. Thence westerly along a line parallel to the center line of said railway company, and 150 feet distance therefrom, 160 feet, thence southerly 775 feet, except a strip 400 feet in width, thence westerly at right angles 825 feet, thence northerly 775 feet, except a strip 400 feet in width and commencing at a point 375 feet from the last point of beginning, being 250 feet southerly and 150 feet northerly and parallel to the center line of said Northern Pacific Railway's main line, as now surveyed and located as aforesaid. Thence at right angles 450 feet, thence at right angles 750 feet to the place of beginning, comprising blocks one to ten inclusive, and designated on the within plat as Streeter, Stutsman County, North Dakota.
