

I, Donald Wenzel, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of Reile Acres, do declare and make known that said plat is in the N.E. 1/4 of section 20, T140N, R64W, in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at a point on the North line of the N.E. 1/4 of section 20, T140N, R64W, that is 22 feet East of the N.W. corner of said N.E. 1/4, hence S 89° 44' E along said North line for a distance of 284 feet, hence due South for a distance of 376 feet, hence N 09° 44' W for a distance of 127 feet, hence South for a distance of 214 feet, hence N 89° 44' W for a distance of 157 feet, hence due North for a distance of 590 feet to the point of beginning. Said parcel contains 3.22 acres, more or less, and is shown on the attached plat.
