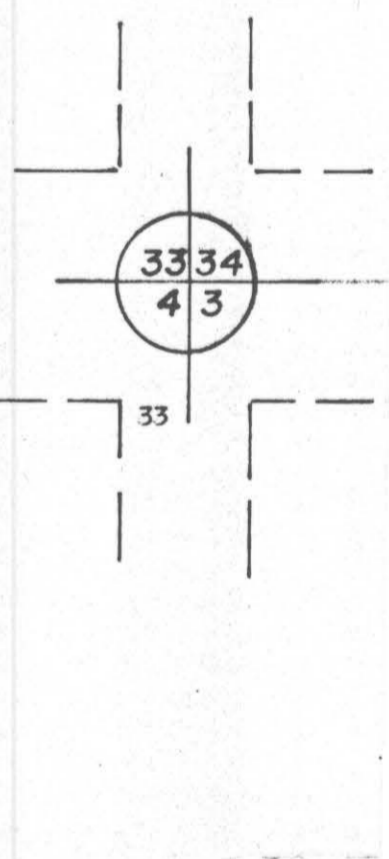
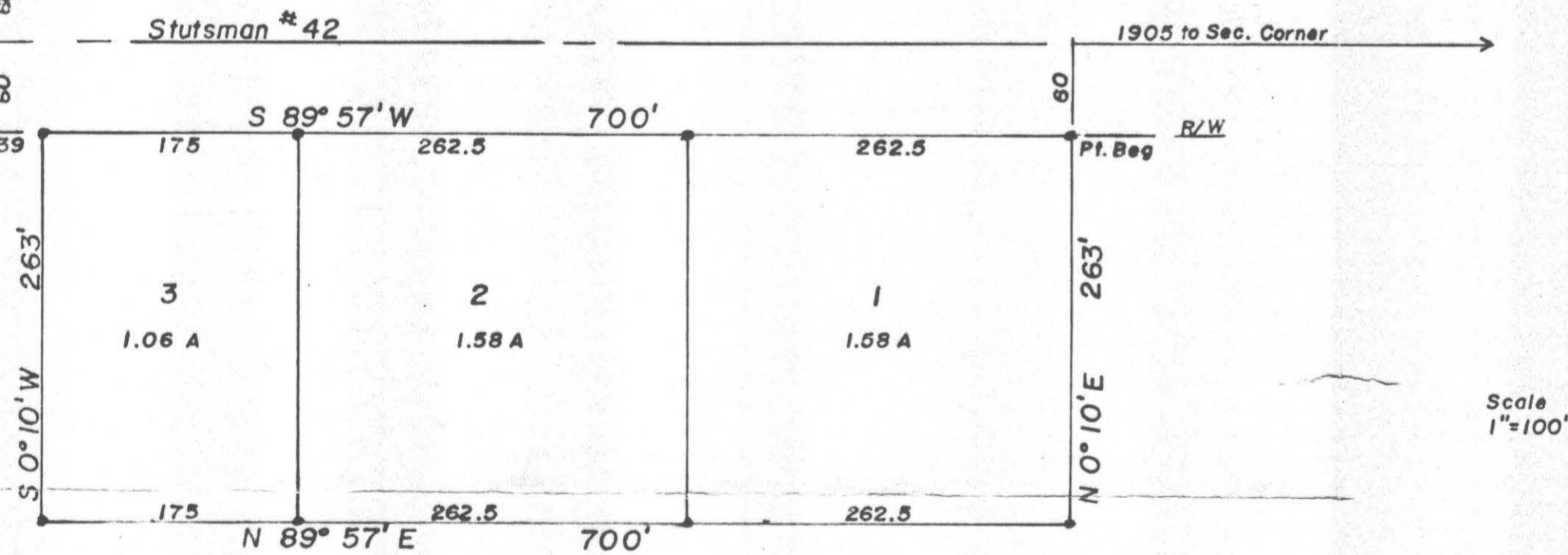

SURVEYORS CERTIFICATE:

I, Donald Henas, a Registered Professional Engineer and Land Surveyor in the State of North Dakota, and as surveyor of the attached plat of SORENSON SUBDIVISION do declare and make known that said plat is in Govt. Lot #2 in the N.E. 1/4 of Section 4, T141N, R64W, in Stutsman County, North Dakota, and is more particularly described as follows:

Beginning at a point that is S 89° 57' W along the North line of said Section 4 a distance of 1905 feet and S 0° 10' W a distance of 60 feet from the N.E. corner of said Section 4, T141N, R64W, hence from this point of beginning S 89° 57' W along the South R/W line of Stutsman County Highway #42 for a distance of 700 feet, hence S 0° 10' W for a distance of 263 feet, hence N 89° 57' E for a distance of 700 feet, hence N 0° 10' E for a distance of 263 feet to the point of beginning. Said parcel contains 4.22 acres, more or less, and is shown on the attached plat.

I further certify that this plat of SORENSON SUBDIVISION in the N.E. 1/4 of Section 4, T141N, R64W, was made by me from an actual survey thereof and that it is correct and true to the best of my knowledge.
