

SPIRIT INN ADDITION SEL SECTION 31, T142N, R62W SPIRITWOOD LAKE, NORTH DAKOTA

The parties set forth hereon as owner and proprietor of the land hereinafter described together with LeRoy H. Kautz, Interstate Engineering Inc., a Registered Land Surveyor in the State of North Dakota; hereby declare and make known that said owner and proprietor recently caused to be suddivided a portion of land in the southeast quarter of Section 31, T142N, R62W in Stuteman County, North Dakota hereinafter referred to as "Spirit Inn Addition". The plat thereof which is hereby attached was made by said LeRoy H. Kautz in accordance with the statutes of the State of North Dakota, in such case made and provided a description of the situation and boundaries of said plat being as follows:

DESCRIPTION OF SUBDIVIDED AREA OF SPIRIT INN ADDITION SPIRITWOOD LAKF, NORTH DAKOTA

A parcel of land located within the SE4 of Section 31, T1/2N, R62W of the fifth principal meridian, Stutsman County, North Dakota more particularly described as follows:

Commencing at the southeast corner of said Section 31; thence NO°20'10"W along the east line of said Section 31 a distance of 1,068,88' to the true point of beginning; thence S41°11'30"W a distance of 226.12 feet to the point of curve; thence going southwesterly and deflecting right along a 10°11'04" curve a distance of 375.65 feet to the point of tangent; thence S79°27'00"W a distance of 225.00 feet to the point of curve; thence going westerly and deflecting right along a 12°13'04" curve a distance of 480.02 feet to the point of tangent; thence N41°54'10"W a distance of 352.18 feet to a point; thence S89°02'20"W h distance of 104.83 feet to a point; thence S0°57'40"E a distance of 301.00 feet to a point; thence S89°02'20"W a distance of 709.10 feet to a point; thence S0°57'40"E a distance of the county road; thence S89°51'00"W along the said county road right-of-way line a distance of 380.00 feet to a point; thence NO057'40"W & distance of 331.51 feet to a point; thence S8902'20"W a distance of 723.10 feet to a point; thence NO057'40"W a distance of 245.65 feet to a point; thence N12 45'CO"E a distance of 438.17 feet to a point on the Spiritwood Lake Shoreline "which is the 1975 high water line"; thence following the said high water shoreline of Spiritwood Lake N51°33'00"E a distance of 255.45 feet to a point; thence N45°27'45"E a distance of 216.25 feet to a point; thence N56°07'49"E a distance of 127.74 feet to a point; thence N67°41'48"E a distance of 238.97 feet to a point; thence N78°13'44"E a distance of 220.25 feet to a point; thence S51°43' 15"E a distance of 211.35 feet to a point; thence S40°10'08"E a distance of 91.18 feet to a point; thence S8°47'00"E a distance of 124.49 feet to a point; thence \$38°39'28"E a distance of 248.13 feet to a point; thence \$40°03'12"E a distance of 163.15 feet to a point; thence \$70°24'39"E a distance of 114.53 feet to a point; thence S84°50'43"E a distance of 77.43 feet to a point; thence N75°41'38"E a distance of 163.95 feet to a point; thence N61°01'00"E a distance of 233.91 feet to a point; thence N44°47'13"E a distance of 193.23 feet to a point thence N39°21'00"E a distance of 233.40 feet to a point thence N33°29'30"E a distance of 124.60 feet to a point on said high water shoreline of Spiritwood Lake and and the east line of said Section 31; thence S0°20'10"E along the said east line of said Section 31 a distance of 399.17 feet plus or minus to the point of beginning.
