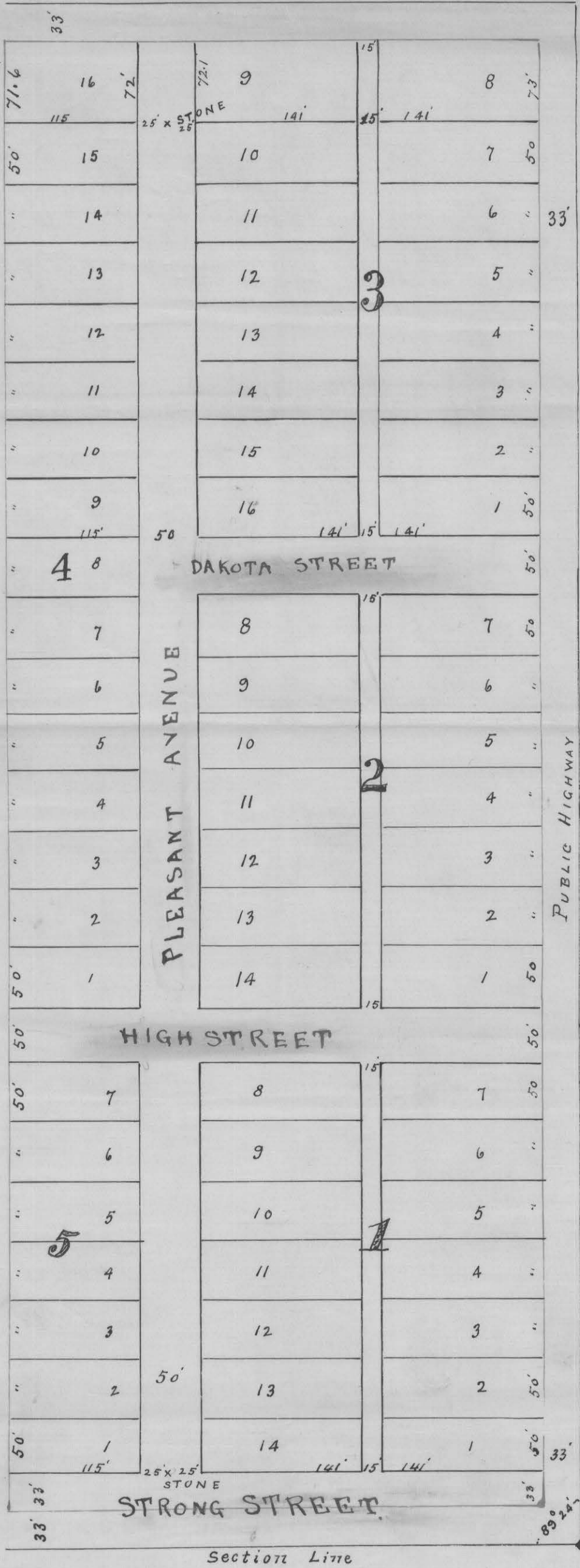


STRONG AND NICHOLS SUBDIVISION
