 quarter of section No 24 Township 14 N Range 106 W and is more particularly located as  
 follows Beginning at the South East corner of the South West quarter of said section No 24 thence North 0° 06' west 2675.5  
 feet to a point in the center of said section No 24 thence North 89° 33' west 1309.5 feet following the line dividing said section  
 No 24 equally north and south and 6 or more miles between the center of the section and the quarter corner of the  
 west side of said section No 24 thence North 0° 08' east 2687 feet along the line dividing the South West quarter equally east  
 and west to a point midway between the South West corner of said section No 24 and the quarter corner on the South side  
 of said section No 24 thence North 89° 37' east 1308 feet along the South side of said section No 24 to the place of beginning

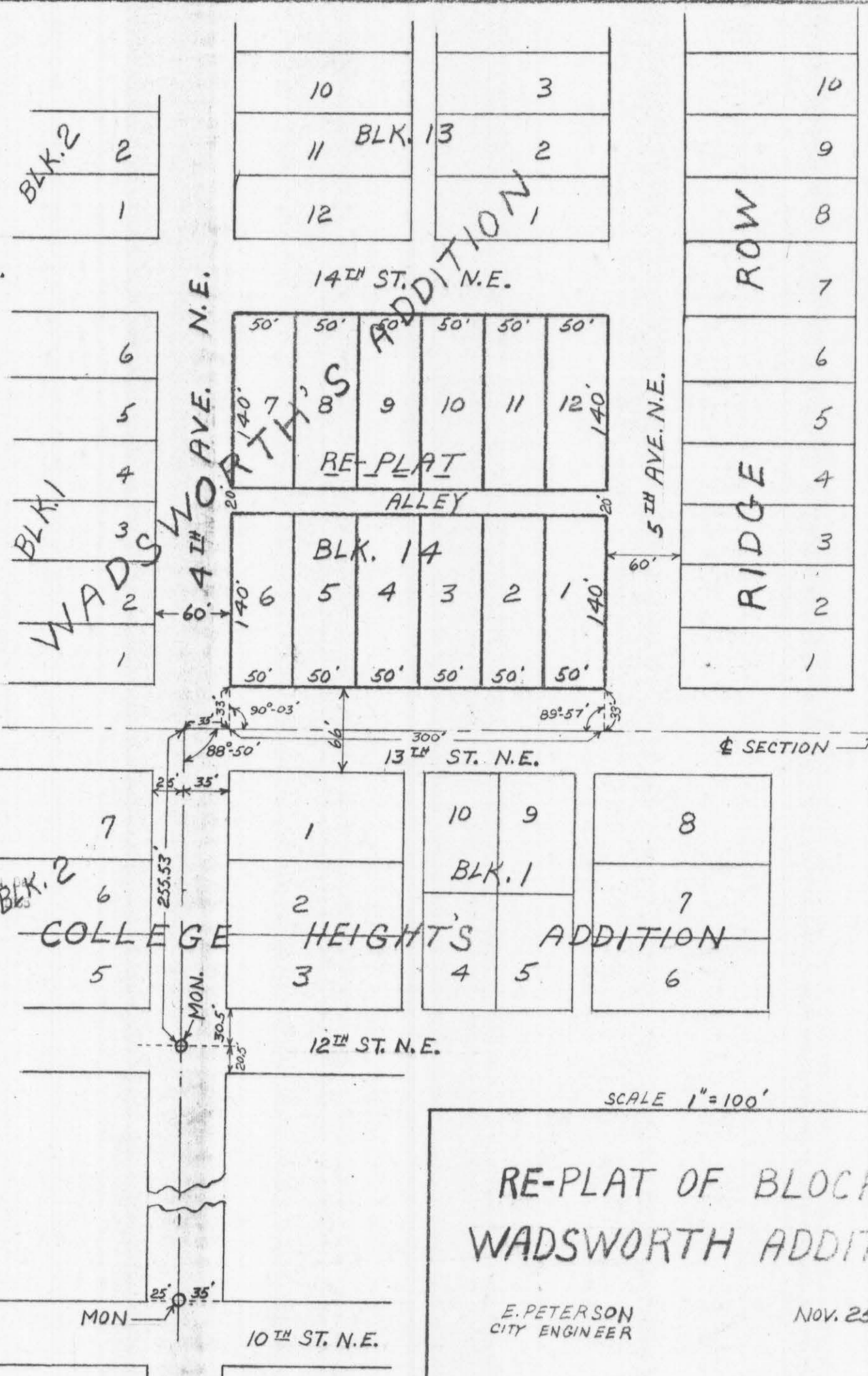
