Beginning at the northwest corner of Lot 4, Johnson Addition to the City of Jamestown, thence N0\*27'17"E along the east right-of-way of Fourth Avenue Northwest for a distance of 200.00 feet to an iron monument; thence S89\*47'40"E, 324.00 feet to an iron monument; thence S0\*27'17"W for a distance of 200.00 feet to an iron monument; thence N89\*47'40"W for a distance of 324.00 feet to the point of beginning.


